Dear Councilman Matera:

Under date of July 7, 1961 we received an Official Memorandum-City Clerk's Office from the Committee on Public Works to which was attached a petition from D. Taglione & Sons, Inc. requesting approval of the Fruit Hill Terrace Plat bordering on Woonasquatucket Avenue and Josephine Street. Josephine Street which is now 20 feet wide will be widened 20 feet on the north side resulting in a street width of 40 feet if the Plat is approved.

At the present time, we have a 6-inch Cast Iron main in Josephine Street from Woonasquatucket Avenue to Hershel Street. An extension of the Josephine Street main from Hershel Street westerly 168 feet is now on our construction schedule. This proposed extension will result in water service to all the lots shown on the Plat.
