No. 192 **AN ORDINANCE** REQUESTING THE SECRETARY OF STATE TO SUBMIT TO THE VOTERS AT THE GENERAL ELECTION TO BE HELD TUESDAY, NOVEMBER 4, 1958, A REQUEST FOR APPROVAL OF BONDS FOR THE REDEVELOPMENT REVOLVING FUND IN THE SUM OF THREE MILLION FIVE HUNDRED THOUSAND (\$3,500,000.) DOLLARS TOGETHER WITH TWO MILLION FIVE HUNDRED THOUSAND (\$2,500,000.) DOLLARS HERETOFORE AUTHORIZED.

Be it ordained by the City of Providence:

Section 1. The Secretary of State is hereby requested to submit the following question to the qualified electors of the City of Providence at the General Election to be held in the City of Providence, Tuesday, November 4, 1958, viz:

"Shall the City of Providence be authorized to issue bonds in a sum not exceeding three million five hundred thousand dollars (\$3,500,000.) for the Redevelopment Revolving Fund authorized by Title 45, Chapter 33, Section 1, of the General Laws of 1956, in addition to bonds in a sum not exceeding two million five hundred thousand dollars (\$2,500,000.) heretofore authorized by the voters of the City at a special election held June 9, 1955; and shall the proceeds of the sale of said issues of bonds be used to effectuate any or all of the purposes and provisions of the "Redevelopment Act of 1956"?"

Sec. 2. The City Clerk is directed to transmit to the Secretary of State forthwith upon the passage of this Ordinance a certified copy thereof.

Sec. 3. This Ordinance shall take effect upon its passage, and all Ordinances and Resolutions and parts of either, inconsistent herewith are hereby repealed.

SEC. 848.1 - WORKING STRESSES. In the design and construction of a reinforced concrete building or structure, the allowable working stresses shall be as specified in the ACI-318-56 in Appendix B for Class A, B or C concrete shall not be exceeded and the design shall conform to accepted engineering practice.

On Page 207

SEC. 848.3 - FIELD TESTS. The Director may require reasonable tests of the concrete during installation to check the materials, methods of installation and quality of the concrete; but not less than three (3) specimens shall be made for each test, nor less than one (1) test for each day or two hundred fifty (250) cubic yards of concrete or part thereof.
