





We would appreciate your placing this request on the Council agenda at the earliest date possible. If you have any questions or need further information please feel free to contact me.







PLAT 75



This letter will serve to respond to your October 6, 1989 letter regarding the proposed resolution that the name of Cemetary Street, from the freeway line to the Moshassuck River Bridge, be changed to Bonanza Way.

As a rule, the Postal Service discourages such changes, as they impact negatively on our mail processing and delivery capabilities. This is due in part to the reluctance of the affected customers to notify all their correspondents of the new street name.

In this instance because the area is being redeveloped, and there are no other residents or businesses affected by this change, we recommend approval of this resolution.

I would like to express my appreciation for your notifying the Postal Service of the proposed resolution for the city, and I hope our input is of assistance to you and the City Council in making a decision. If it would be beneficial, we would be more than willing to sit down to discuss this or any other address issues with you or members of your committee.

Subject: Proposed Change of Cemetery Street to Bonanza Way

Sir: Attached is a copy of the correspondence with regards to the name change as stated in the subject.

After reviewing the correspondence and an area check, I see no problem with the name change.

I would like to add that part of the area which is to be renamed is in the middle of the existing Cemetery Street, which may be confusing to parties using the roadway in the past. As you are aware, Cemetery Street already is split in name from North Main Street, with a section of the street documented as Frost Street. This will become the first straight section of roadway in the City of Providence with three (3) names.

I would suggest that Promfret Street which is actually the street that the new bus station will be located should be changed to Bonanza Way, or rename the entire section of Cemetery Street from Frost Street to the highway. This would leave the name Cemetery Street in tact from North Main Street to where it meets Frost Street and the new Bonanza Way. Refer to Diagram Attached.
