
Gentlemen:

The Traffic Engineering Department has reviewed the request for establishing Chaffee Street as a one-way street in a westerly direction from Appleton Street to Manton Avenue.

Chaffee Street has a pavement width of 20 feet from curb to curb. Parking is prohibited on one side of the street and permitted on the other side of the street. This leaves a maximum clear space for moving traffic of approximately 12 to 13 feet, which is an insufficient amount of space for two-way traffic. At anytime when there are a number of parked vehicles on the permitted side and vehicles attempt to use the street in both directions at the same time, it is necessary for one of the vehicles to either find a driveway or other space to pull into in order to permit the other vehicle to pass. During periods when parents are picking up or leaving children at the St. Adelbert's School at the corner of Chaffee Street and Capron Street, the problem of congestion on Chaffee Street can become very acute due to this very restricted width on Chaffee Street.

It is therefore recommended that Chaffee Street be made a one-way street in a westerly direction from Appleton Street to Manton Avenue.
