No. 64 **AN ORDINANCE** AMENDING THE APPROPRIATION. ORDINANCE CHAPTER 1981-39, EFFECTIVE JULY 20, 1981, BY TRANSFERRING THE SUM OF SIX HUNDRED THIRTY THOUSAND DOLLARS (\$630,000) WITHIN THE PUBLIC WORKS WASTE COLLECTION ACCOUNT FROM 05-07 ITEM "0" TO 05-07 ITEM "189".

Be it ordained by the City of Providence:

SECTION 1. Chapter 1981-39, of the Ordinances of the City of Providence, effective July 20, 1981, entitled: "An Ordinance Making an Appropriation of One Hundred Forty-Nine Million, Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars and Nine Cents (\$149,862,122.09) as amended, is hereby further amended by transferring the Sum of Six Hundred Thirty Thousand Dollars (\$630,000) within the Public Works Waste Collection Account from 05-07 Item "0" to 05-07 Item "189".

SECTION 2. This Ordinance shall take effect upon its Passage.


Dear Mr. Baron:
