



ORDINANCE(S) SECOND READING

An Ordinance regarding Observance of the first night of the Passover Holiday.

Section 1:

The Code of Ordinances is amended to add a new Section 2-10.1, which provides as follows:

2-10.1. First Night of Passover

The City Clerk will maintain in the City Council's calendar information about the occurrence of the first night of Passover each year. For the period 2018-2035, those dates are as follows:

When scheduling night-time meetings of the City Council, or its committees, or public hearings, the City Clerk will make best efforts to avoid scheduling on the first night of Passover. At those times when it is necessary to schedule a meeting on the first night of Passover due to the absence of a feasible alternative, the Clerk shall note on the agenda and at the meeting itself that the meeting took place on the first night of Passover because there was a scheduling conflict that could not be reasonably avoided.

Section 2. This Ordinance will take effect upon passage.

COUNCILMAN ZURIER

An Ordinance in Amendment of Chapter 12 of the Code of Ordinances of the City of Providence, Entitled: "Health and Sanitation," Article III, "Garbage, Trash and Refuse", Section 12-89, Disposal of Leaf and Yard Debris.

Sec. 12-89. - Disposal of leaf and yard debris.

(a) *Disposal to be conducted in environmentally sound manner.* The city finds that disposal of leaf and yard debris should be conducted in an environmentally sound manner and wishes to institute a comprehensive plan for such disposal with as little negative environmental impact as practicable.

(b) *Definitions.*

Acceptable leaf/yard debris shall mean leaf/yard debris free of contamination by rubbish, trash, garbage, construction/demolition debris, tree limbs larger than four (4) inches in diameter, tree stumps or any other material that does not constitute leaf/yard debris.

Leaf/yard debris shall consist of leaves, grass, weeds, vegetable and flower garden herbaceous debris and remnants, plant trimmings, small brush and hedge clippings, chipped or shredded tree or shrubbery branches and other small landscape trimmings and cuttings.

(c) *Containers.*

Acceptable yard/leaf debris shall be placed in municipally approved recyclable, reusable or disposable biodegradable containers for collection. Every person shall place yard debris at curbside. It shall be separate and apart from all other disposable and recyclable materials.

(d) *Plastic bags prohibited.*

Acceptable leaf/yard debris shall not be placed for disposal in plastic bags of any nature.

(e) *Disposal onto sidewalks and streets prohibited.*

No person shall cast, place, sweep, blow or deposit in any manner leaf/yard debris in or upon any street, sidewalk, alley, park, drain, sewer, gutter or receiving basin in the City.

(f) *Enforcement.*

The director of the department of public works or his/her designee is hereby authorized to promulgate rules and regulations so as to effect the purpose of this section. Property owners will be held responsible for prohibited activity conducted by others who have been hired to maintain the owner's property.

(g) *Penalty.*

Any violations of the provisions of this section shall be punishable as stated in section 12-61.2 of the Code of Ordinances of the City of Providence.

An Ordinance in Amendment of the Code of Ordinances of the City of Providence
Chapter 15, by adding Section 15-7.

SECTION 1. Chapter 15, Article I of the Code of Ordinances of the City of Providence is hereby amended by adding Section 15-17, which reads as follows:

15-17. Traffic on certain streets . The following roadways shall be restricted to local traffic only, and no vehicular traffic shall be permitted except for motor vehicles requiring access to properties on the roadways, and vehicles providing public services:

- Jenckes Street in both directions between Benefit Street and Congdon Street

(b) The director of the department of public works will take such action as necessary to effectuate this ordinance, including providing proper public notice prior to restricting vehicular traffic, and erecting and maintaining signs controlling access to the roadways.

(c) The operator of a vehicle violating this section shall be subject to the penalties for "violation of moving vehicle traffic regulation" under Ordinance Chapter 15, Section 15-2(a).

SECTION 2. This ordinance shall be effective upon passage.

COUNCILMAN IGLIOZZI, (By Request):

An Ordinance Relating To Article IV, Chapter 17, Section 17-192(F) of the Code of Ordinances (Disability Waiver Request) (Deborah Marandola).

SECTION 1. Notwithstanding the language of Section 17-192(f) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident, the Retirement Board of the City of Providence may consider and act upon the accidental disability retirement application of Debra Marandola, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards, and practices relating to accidental disability retirement applications.

SECTION 3. This Ordinance shall take effect upon passage.

Resolution Endorsing and Urging Passage by the General Assembly of House Bill 2018 H-7501 and Senate Bill 2018 S-2419, An Act Relating to Elections - Conduct of Election and Voting Equipment and Supplies.

WHEREAS, On February 8, 2018 Rhode Island Representatives Joseph J. Solomon Jr. (D), Kenneth A. Marshall (D), Robert D. Phillips (D), Jean Phillippe Barros (D), and David A. Coughlin (D) introduced HB 7501; and

WHEREAS, On February 15, 2018 Rhode Island Senators Erin Lynch Prata (D), Jeanine Calkin (D), and Gayle L. Goldin (D) introduced SB 2419; and

WHEREAS, Passage of these bills would amend Rhode Island General Laws to establish an in-person early voting period 20 days prior to a general or primary election, including the weekend before a general or primary, at locations determined by local boards and approved by the state board; and

WHEREAS, At least 33 states, plus the District of Columbia, provide citizens with an opportunity to vote early and in-person without an excuse; and

WHEREAS, Nationally, 46% of voters cast their ballots in advance of Election Day in 2016; and

WHEREAS, Rhode Island saw more than 15,000 voters cast emergency mail ballots in 2016, up from fewer than 6,000 in 2012 during the 20-day period prior to Election Day; and

WHEREAS, Early voting would remove barriers to voting for individuals unable to vote in-person on Election Day; and

WHEREAS, Additionally, in-person early voting will ease some of the stresses on the voting system on Election Day and provides an opportunity for early identification and correction of registration errors; and

WHEREAS, As public servants and the elected representatives of the people of Providence, the City Council has an obligation to ensure that citizens are able to easily exercise their right to vote prior to and on Election Day of an election year.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council supports Rhode Island House Bill 7501 and Senate Bill 2419 to allow for in-person early voting at pre-determined locations.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be sent to the elected Rhode Island House and Senate representatives of the City of Providence.

Resolution Endorsing and Urging Passage by the General Assembly of Senate Bill 2018 S-2301 and House Bill 2018 H-7528, An Act Relating to Property - Fair Housing Practices.

WHEREAS, On February 1, 2018, Rhode Island Senators Harold M. Metts (D), Elizabeth A. Crowley (D), Ana B. Quezada (D), Frank A. Ciccone III (D), and Paul V. Jabour (D) introduced SB 2301; and

WHEREAS, On February 9, 2018 Rhode Island Representatives Anastasia P. Williams (D), K. Joseph Shekarchi (D), Raymond A. Hull (D), Marcia Ranglin-Vassell, and Aaron Regunberg (D) introduced HB 7528; and

WHEREAS, Passage of these bills would amend Rhode Island General Laws to prohibit discrimination in housing against those individuals who have a lawful source of income; and

WHEREAS, The bills define "lawful source of income" as "income or other assistance derived from Social Security; Supplemental Security Income; any other federal, state or local general public assistance, including medical assistance; any federal, state or local housing assistance, including Section 8 Housing ..., and any other rental assistance; child support; or alimony"; and

WHEREAS, "Lawful source of income" would be added to the list of statuses landlords currently cannot use as a basis for their decisions on whom they will rent to; and

WHEREAS, Other New England states, such as Massachusetts, Connecticut, Maine, and Vermont, have long outlawed this form of housing discrimination; and

WHEREAS, In Rhode Island, 9,300 households currently have vouchers and, according to the Rhode Island Commission for Human Rights, 70 percent of voucher holders are families with children, 87 percent are households headed by women, and 20 percent are black; and

WHEREAS, According to Rhode Island Housing, over 50 percent of voucher holders have been turned down for housing due to a "No Section 8" policy and the proposed bills would "remove an important barrier to housing affordability"; and

WHEREAS, In a letter of support for the bills, the Executive Director of Rhode Island Housing stated that the bill will "prohibit reliance on stereotypes about recipients of public assistance in determining an applicant's suitability as a tenant"; and

WHEREAS, The Rhode Island Association of Realtors also showcased support for the bills, stating that they “mitigate administrative burdens placed on landlords”; and

WHEREAS, As public servants and the elected representatives of the people of Providence, the City Council has an obligation to ensure that residents have fair and equitable access to housing, regardless of their economic means.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council supports Rhode Island Senate Bill 2301 and House Bill 7528 to prohibit housing discrimination based on source of income.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be sent to the elected Rhode Island House and Senate representatives of the City of Providence.


