


Gentlemen:





Dear Mayor Reynolds:

You have, no doubt, been in contact with Michael Hallward since we allowed our option for property on Field's Point to expire and know that we do not plan to ask for a renewal of our option. Because we are aware of the disappointment our decision might cause to many in the Providence area we have purposely neglected writing to you in the hope that we might develop a more definitive course of action which we could then report to you.

Throughout most of our option period for the Providence property we were negotiating for the purchase of a cannery in Oregon. This cannery, producing other seafood products, was compatible with our existing products and highly desirable as an extension of our corporate activities. It, in fact, took precedence over an east coast plant as an outlet for our administrative talents at this time. These negotiations were successfully concluded in mid-December.


Now, with regard to our future intentions. We think it an unfair imposition to request an extension of our option in Providence. You have a large investment in excellent waterfront facilities that should be put to productive use as soon as possible. Though we have not changed, in the least, our opinion of the economic feasibility of an east coast tuna cannery, we cannot at this time give you a firm estimate of when we will be prepared to make such a move. If our decision should come soon, we hope to resume our relations with you.

Mr. Hallward, Mr. Hampson and all the people who have supplied us with data that would be helpful to us in reaching a decision to locate in Providence have done a magnificent job. With the tireless effort of men like these

and the progressive policies pursued by your administration, your harbor development should expand rapidly. I sincerely hope that you will have space for us when we are ready to expand to that coast.

Gentlemen:

In accordance with Resolution No. 102 of your honorable body approved February 8, 1963, the Redevelopment Agency has reviewed the provisions of the Official Redevelopment Plan for the Lippitt Hill Project Area, as recently revised, to determine whether any additional land may be made available for school and recreation purposes within the cleared sections of the project area now held by this Agency, and exclusive of the rehabilitation sections where our consent to such additional acquisition could not be given.

The entire area cleared by this Agency within the Lippitt Hill Project Area has been definitely committed by us for disposition at approved prices to redevelopers. The entire cleared acreage west of Camp Street has been reserved for redevelopment by University Heights, Incorporated for residential and commercial purposes.

We appreciate the acknowledgement contained within your recent Resolution No. 102, to the effect that no part of the residential area now being rehabilitated by individual owners in cooperation with this Agency can be considered for such additional acquisition. The proposed connecting street along the easterly edge of the school and recreation site is needed for neighborhood access from Carrington Avenue to Lippitt, Howell and Dwight Streets, as shown on the maps accompanying the report on modifications of the Official Redevelopment Plan approved December 21, 1962. Improvements actually accomplished to date on all four of the residential properties adjoining this connecting street would make its relocation eastward particularly infeasible.


We should also point out that the properties fronting upon the southerly side of Doyle Avenue, east of Camp Street and adjoining the available site, were found upon inspection to be too high in quality to be included within the Lippitt Hill Project Area or within its rehabilitation sections. We understand that these properties have been improved since that time with respect to their compliance

with the city's housing code.

We respectfully call your attention to the fact that the existing 5.12 acres is considerably larger than the 4.50 acre site provided two years ago in South Providence for both purposes, including a playground for the elementary school age children together with the most recently constructed Mary Fogarty School containing a 700-pupil capacity. Moreover, this site is slightly larger than the 5.08 acres used by the Joslin Street School which although having only a 600-pupil capacity, includes a swimming pool and related facilities. To this time no official information has been received by us to warrant the conclusion of inadequacy for school and recreation purposes of the present Lippitt Hill site. If the architect is given a reasonable opportunity to study the present site, it is very probable that the present site will be adequate for the construction of excellent facilities for both school and recreational purposes.


