**No. 82 AN ORDINANCE** AMENDING CHAPTER 544 OF 1951

BY CHANGING FROM A C-1 LIMITED COMMERCIAL ZONE TO A C-4 HEAVY COMMERCIAL ZONE, LOTS 276, 277, 324 AND 325, AS SET OUT AND DELINEATED ON CITY ASSESSOR'S PLAT 72; SAID LOTS BEING BOUNDED BY BRANCH AVENUE, SILVER SPRING STREET AND METCALF STREET.

*Approved* February 24, 1970

***Be it ordained by the City of Providence:***

SECTION 1. The Zoning Map accompanying and made a part of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, as heretofore amended, and entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations", is hereby further amended by changing from a C-1 Limited Commercial Zone to a C-4 Heavy Commercial Zone, Lots 276, 277, 324 and 325, as set out and delineated on City Assessor's Plat 72; said lots being bounded by Branch Avenue, Silver Spring Street and Metcalf Street, bounded and described as follows:

Beginning at the northwesterly corner of Branch Avenue and Silver Spring Street at the southeasterly corner of Lot 276 on City Assessor's Plat 72; thence westerly along the northerly line of Branch Avenue to the northeasterly corner of Branch Avenue and Metcalf Street at the southwesterly corner of Lot 325; thence northerly along the easterly line of Metcalf Street to the northwesterly corner of Lot 325; thence easterly along the southerly lines of Lots 323 and 278 to the westerly line of Silver Spring Street at the northeasterly corner of Lot 276; thence southerly along the westerly line of Silver Spring Street to the northwesterly corner of Silver Spring Street and Branch Avenue at the southeasterly corner of Lot 276 and the point and place of beginning.

SECTION 2. This Ordinance shall take effect upon its passage.

**TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:**

*The undersigned respectfully petitions your honorable body*

AS FOLLOWS:

JOHN DiMARZIO and wife, MARY DiMARZIO, of 176 Toledo Avenue, Pawtucket, R. I., are the owners of 291, 293, 295 and 297 Branch Avenue. The lots are numbered 276 and 277 on Plat No. 72 of the Providence Tax Assessors currently in use. There is a three-story frame dwelling on Lot 276 and a two and one-half story frame dwelling on Lot 277. Lot 276 is at the northwesterly corner of Silver Spring Street and Branch Avenue. Lot 277 fronts on Branch Avenue. Said lots adjoin and together contain 7,667 square feet and are in a C-1 zone. *APM*

THOMAS BORRELLI and wife, SANTINA BORRELLI, of 299 Branch Avenue, Providence, R. I., are the owners of 299, 301 and 301 1/2 Branch Avenue. The lot is numbered 324 on said Plat 72. It fronts on Branch Avenue and adjoins the land of DiMarzio referred to in the previous paragraph on the west. There is a building containing a three-story frame dwelling with detached garage on the lot. The lot contains 3,393 square feet and is also in a C-1 zone. *APM*

EMILIO CORVESE and wife, DOMENICA CORVESE, of 315 Branch Avenue, Providence, R. I., are the owners of 303 and 305 Branch Avenue. The lot is numbered 325 on said Plat 72. It adjoins the Borrelli premises referred to in the preceding paragraph on the west. There is a three-story frame dwelling with detached garage on the lot. It is at the northeasterly corner of Metcalf Street and Branch Avenue. It fronts on both Branch Avenue and on Metcalf Street, it contains 3,236 square feet, and is in a C-1 zone. *APM*

The four lots as one parcel bound southeasterly on Silver Spring Street One Hundred and 77/100 (100.77) feet; southwesterly on Branch Avenue One Hundred Twenty-Two and 91/100 (122.91) feet; northwesterly on Metcalf Street Seventy-Seven and 89/100 (77.89) feet; and northeasterly One Hundred Sixty and 08/100 (160.08) feet on land of others and contains 14,296 square feet of land.

The undersigned respectfully petitions this Honorable City Council of the City of Providence to change the zone of each of said four lots, i.e. Lots 276, 277, 324 and 325 on City of Providence Tax Assessors Plat 72 from C-1 to C-4. *APM*


Gentlemen:

This referral from the Committee on Ordinances is a request to change the zoning on four lots located in Assessor's Plat 72 from C-1 (limited commercial) to C-4 (heavy commercial). The lots are numbered 276, 277, 324 and 325 and are at 291-297 Branch Avenue between Metcalf Street and Silver Spring Street.

A photographic and inspection survey revealed that Lot 276 contains a 3 story frame dwelling with a store front, Lot 324 contains a 3 story frame dwelling with a store front and a detached garage, and Lot 325 contains a 3 story frame dwelling with store front and attached garage. All the buildings are in fair condition and the neighborhood is mixed industrial, commercial and residential, and in fair condition.

Lot 325 falls within the boundaries of the preliminary right of way of the Silver Spring Street loop as proposed in the Master Plan for Circulation. Since implementation of this proposal would require acquisition of Lot 325, new construction should not be encouraged thereon. However, no objection to the rezoning of the other three lots is offered.

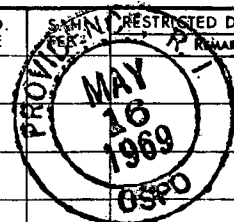

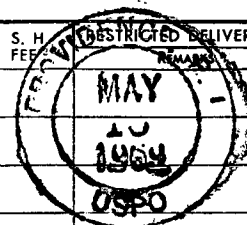

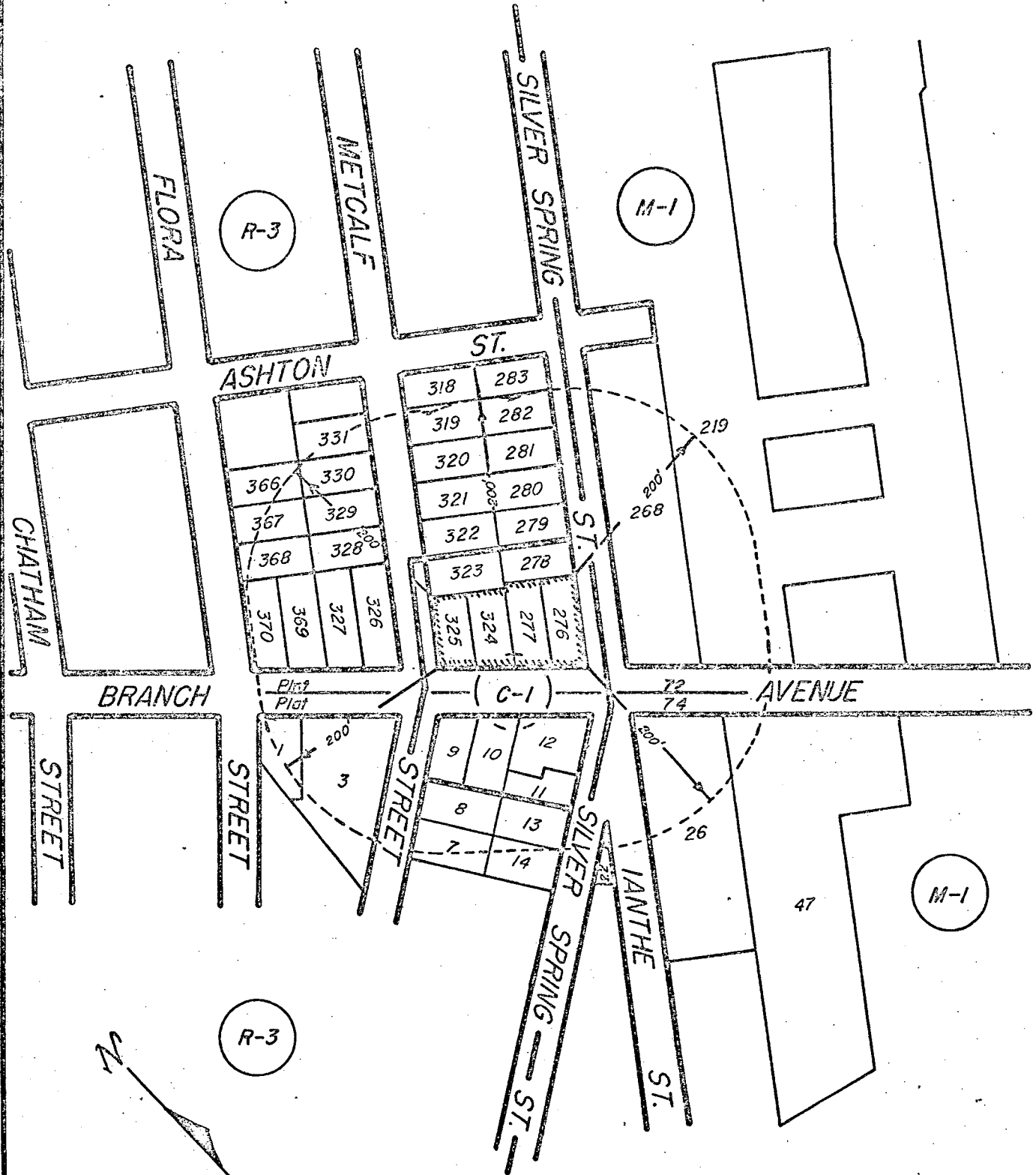

THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, RHODE ISLAND,  
EFFECTIVE OCTOBER 21, 1968.

*Be it ordained by the City of Providence:*

\* SECTION 1. Section 12-117 of the Code of Ordinances of the City of Providence, Rhode Island, effective October 21, 1968, is hereby amended to read as follows:

"Sec. 12-117. Throwing rat or vermin harborage on vacant lots, streets, lakes, other property.

No person shall throw, place or deposit or permit any tenant or person under his control or employment to throw, place or deposit any putrid substance, night soil, filth or any kind, garbage, rubbish, refuse piles, old lumber or other rat or vermin harborage or any unwholesome material, in or upon any lot, vacant lot, alley, lane, sidewalk or street, canal, lake or river, or upon any private lot or public ground within the City without the consent of the Director of Public Works

No person or persons shall allow any lot, vacant lot, alley, lane, sidewalk or street, canal, lake or river owned by them to become covered with any putrid substance, night soil, filth of any kind, garbage, rubbish, refuse piles, old lumber or other rat or vermin harborage or any unwholesome material which endangers the general health and welfare of the public.

The Vermin Control Officer in the Environment Control Enforcement Division under the control of the Director of Public Works shall cause to be examined all lots, vacant lots, alleys, lanes, sidewalks and streets, canals, lakes or rivers, private lots and public grounds within the limits of the City. When said Officer finds any putrid substance, night soil, filth of any kind, garbage, rubbish, refuse piles, old lumber or other rat or vermin harborage or any unwholesome material placed or deposited upon any lots, vacant lots, alleys, lanes, sidewalks and streets, canals, lakes or rivers, private lots and public grounds which endangers the general health

and welfare of the public, said officer shall order the owner or owners to remove said materials and if the said owner or owners refuse to remove said materials within three (3) days, said officer may cause the same to be removed at the expense of the owner. Said officer shall place a lien upon the land for the cost of removing the materials.

No owner or owners shall neglect or refuse to remove therefrom any materials, after being ordered to do so by the Vermin Control Officer or obstruct any member under the control of the Vermin Control Officer in the discharge of their duties. Every day, in excess of three (3), that any such owner or owners shall neglect or refuse to remove therefrom any materials after being ordered to do so by said Vermin Control Officer shall be deemed and regarded as a separate offense under this section.

Any order authorized by this ordinance shall be made upon the owner or owners in the following manner: Such order shall be served either by delivering to and leaving with said owner or owners personally a copy of the order, or if such owner or owners are absent from the jurisdiction of the Vermin Control Officer making the order, by mailing such copy to the owner's last known post office address.

Any order herein made shall be subject to appeal by the owner or owners within 48 hours after service of the order. Said appeal shall be taken by filing a petition with the Providence Municipal Court, praying a review of such order and it shall be the duty of such Court to hear the same within three (3) days from the time the petition is filed, and to make such order in the premises as right and justice may require. The party or parties appealing to the Providence Municipal Court shall file with said Court within two (2) days a bond in an amount to be fixed by the Court, to be approved by the Court, conditioned to pay all the costs of such appeal in case such appellant fails to sustain his appeal or the same be dismissed for cause.

SEC. 2. The Vermin Control Officer in the Environment Control Enforcement Division under the control of the Director of Public Works shall cause to be examined all lots, vacant lots, alleys, lanes, sidewalks and streets, canals, lakes or rivers, private lots and public grounds within the limits of the City. When said Officer finds any putrid substance, night soil, filth of any kind, garbage, rubbish, refuse piles, old lumber or other rat or vermin harborage or any unwholesome material placed or deposited upon any

Any order authorized by this ordinance shall be made upon the tenant or tenants in the following manner: Such order shall be served either by delivering to and leaving with said tenant or tenants personally a copy of the order, or if such tenant or tenants are absent from the jurisdiction of the Vermin Control Officer making the order, by mailing such copy to the tenant's last known post office address.

Any order herein made shall be subject to appeal by the tenant or tenants within 48 hours after service of the order. Said appeal shall be taken by filing a petition with the Providence Municipal Court, praying a review of such order, and it shall be the duty of such Court to hear the same within three (3) days from the time the petition is filed, and to make such order in the premises as right and justice may require. The party or parties appealing to the Providence Municipal Court shall file with said Court within two (2) days a bond in an amount to be fixed by the Court, to be approved by the Court, conditioned to pay all the costs of such appeal in case such appellant fails to sustain his appeal or the same be dismissed for cause.
