**AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1986-30 APPROVED JUNE 26, 1986, BY TRANSFERRING VARIOUS SUMS OF MONEY WITHIN VARIOUS DEPARTMENTS, AS AMENDED.

### *Be it ordained by the City of Providence:*

SECTION 1. Chapter 1986-30 of the Ordinances of the City of Providence, as approved June 26, 1986, entitled: "An Ordinance making appropriation of One Hundred Eighty-eight Million, Two Hundred Nine Thousand, Twenty-four Dollars and Seventy-two Cents (\$188,209,024.72). For the Fiscal Year ending June 30, 1987, as amended", is hereby further amended by transferring various sums of money within various departments. This transfer would be effected as follows:
