AN ORDINANCE IN AMENDMENT OF THE APPROPRIATION ORDINANCE CHAPTER 1976-38, APPROVED NOVEMBER 27, 1976, BY APPROPRIATING A SUM NOT TO EXCEED ONE MILLION, SIX HUNDRED THOUSAND DOLLARS, (\$1,600,000.00) TO SCHOOL DEPARTMENT (08-01,) ITEM 0.

~~Be it ordained by the City of Providence:~~

WHEREAS, the protective executive measure which led to the Veto of that Ordinance in amendment of the appropriation Ordinance Chapter 1976-38, approved November 27, 1976, by appropriating a sum not to exceed One Million, Six Hundred Thousand Dollars, (\$1,600,000.00) to School Department 08-01, Item 0, is no longer necessary and accordingly, His Honor the Mayor recommends the adoption of the following as an Emergency Ordinance;

SECTION 1. Chapter 1976-38 of the Ordinance of the City of Providence, as approved November 27, 1976, entitled: "An Ordinance Making Appropriation of \$104,335,240.60 for the support of City Government for the Fiscal Period beginning July 1, 1976, and ending June 30, 1977; is hereby amended by appropriating the sum of One Million, Six Hundred Thousand Dollars, (\$1,600,000.00) to Providence School Department (08-01), Item 0.

SECTION 2. the said sum of One Million, Six Hundred Thousand Dollars, (\$1,600,000.00) as thus added and appropriated shall be obtained by authorizing the City Controller and City Treasurer to transfer One Million, Six Hundred Thousand Dollars, (\$1,600,000.00) from the Reserve Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated Receipts from the Reserve Extraordinary Expenditures Account are hereby increased by One Million, Six Hundred Thousand Dollars, (\$1,600,000.00).

SECTION 4. This Ordinance shall take effect upon its passage.
