RESOLVED, DECREED AND ORDERED:

That the following named Street shown as cross-hatched area on the accompanying plan entitled, "Providence, RI Department of Public Works - Engineering Office, Street Line Section Plan No. 064372, dated January 16, 1987.

VIZ:

Linden Street (portion of), shown as cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway, provided that the New England Telephone and Telegraph Company be granted an easement acceptable to New England Telephone, which will permit retention of its facilities in existing locations with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, if decided by the petitioner that telephone facilities are to be relocated, the petitioner will assume all costs of the relocation; the Water Supply Board shall require full-street width easement from curb to curb and no obstructions, landscaping or improvements shall occur within the easement area to insure that maintenance and repair to the water main can be effectively accomplished; and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, That the Traffic Engineer be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

The City Plan Commission at its January 21, 1987 regular monthly meeting reviewed and evaluated the subject referral from your Committee.

The petitioner is Ms. Alma Felix Green, Managing Partner of Indian Village Housing Development, a joint venture located at 861 Broad Street, Providence, Rhode Island.

The Indian Village Housing Development Project sponsored by the City of Providence has been awarded a \$1,100,000 Housing Development Grant for the development of 36 units of affordable rental housing within the Trinity Gateway Redevelopment Project.

The portion of Linden Street to be abandoned is to be used as a common for this project. The abandonment of the aforesaid portion of Linden Street would not adversely affect the neighborhood traffic patterns and in fact, this abandonment would increase the safety of the proposed communal living environment.

The existing one-family structure at 478 Pine Street will be acquired by the developer upon completion of the project and converted into a cultural center.

Since the proposed abandonment is consistent with the redevelopment plan for the area the Commission voted to advise the Committee on Public Works that no objection is offered to the aforesaid street abandonment under the following conditions:



Therefore, the Department of Public Parks has no objection to the proposed abandonment.



New England Telephone and Telegraph Company will not object to the granting of said petition, provided that in the event the petition is granted, the petitioner will convey an easement acceptable to New England Telephone, which will permit retention of it's facilities in existing locations with the right to inspect, maintain, operate and replace the same and with twenty four hour access to said facilities.

If it is decided by the petitioner that telephone facilities are to be relocated, the petitioner will assume all costs of the relocation.
