AN ORDINANCE

IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1983-4 OF THE ORDINANCE OF THE CITY OF PROVIDENCE APPROVED FEBRUARY 18, 1983 AND ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE SILVER LAKE REVITALIZATION PROJECT" FOR THE ACQUISITION OF LOT 285 ON PLAT 107, 20 RALPH STREET

Be it ordained by the City of Providence:

1. That Chapter 1983-4 of the Ordinances of the City of Providence, approved February 18, 1983 and entitled, "An Ordinance Approving and adopting the Official Redevelopment Plan for the Silver Lake Revitalization Project", as amended, is hereby further amended as follows:

A. To the list of designated properties for acquisition in Section 2, entitled, "Proposed Acquisition" under Chapter E, entitled, "Plan Proposals" contained and set forth on Page 19 of that certain booklet entitled "Silver Lake Revitalization Project, Official Redevelopment Plan, 1983", which is a part of the aforementioned Ordinance, the following properties shall be added:

B. Certain Maps of the Official Redevelopment Plan therein identified, Proposed Acquisition and Disposition shall be amended to include the Proposed Acquisition of the aforementioned lots.

2. That said Chapter 1983-4 of the Ordinances of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.
3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.
