That the following Minute on the life and character of the late Doctor Joseph C. O'Connell be and the same is hereby adopted and ordered inscribed on the records of the City Council and a copy transmitted to the family of the deceased.

MINUTE

JOSEPH CYRIL O'CONNELL was born in Wakefield in our neighboring Commonwealth of Massachusetts on December 24, 1878. After premedical studies at Boston College he enrolled at Harvard Medical School from which he graduated in 1901 with honor. He served his internship in Rhode Island Hospital and thereafter practiced and lived in this city until his death on Thursday, March 3, 1955. Endowed with almost miraculous skill he was marked for his profession. To his natural aptitude he brought application and industry. The combination of these qualities soon established his position in the medical world. In his special field of surgery he became preeminent. No case was too simple--no surgery too complex for his solicitous care.

The financial rewards of an extensive practice were of only incidental interest to him. His real compensation was in the satisfaction of healing the sick. Gratitude was often his only payment for services, yet those services were always available to rich and poor alike.

His industry was almost legendary. For over a half century he worked endlessly and tirelessly. He served and

labored in practically every hospital in the State--
Rhode Island, St. Joseph's, Chapin, Lying In, Butler,
Roger Williams, Miriam, Memorial, Notre Dame, South County
and Westerly.

In spite of the always heavy demands of his work he was
ever ready to respond to civic call. His time and energy
were given freely and willingly to city, state and nation.
For twenty years he was a member of the Providence Board
of Hospital Commissioners acting as secretary during most
of that time. Since 1941 until his death he was chairman
of the Rhode Island Board of Medical Examiners. He was a
major in the Rhode Island National Guard in 1905 and 1906
and a lieutenant in the United States Naval Reserve from
1918 to 1921 during which time he served in France and in Ireland.
His interests embraced almost every segment of our daily life.
He was a past president of the Rhode Island Medical Society and
president of Rhode Island Medical Society Physicians Service
since its organization in 1949. He was an active member of
many social and fraternal groups.

Doctor O'Connell was truly a remarkable man. Humility
and kindness marked his greatness. Success never changed his
genuineness. He was a credit to his family, his church, his race,
his profession, his community--in a word to everything of
which he was a part. His career was one seldom, if ever,
equalled, and certainly never surpassed.

While he had achieved his three score and ten years his
life was still fruitful. To almost the very last day of his
life he actively devoted himself to his work. His amazing
vitality so belied his years that his unexpected death came as
a profound shock. We regret his passing for the public has
lost a noble benefactor and the medical profession an eminent
leader. However, we accept with humble resignation the call
from Almighty God.
