BE IT FURTHER RESOLVED, that such installations be subject to the approval of the Director of Public Works and the Public Service Engineer; provided that the Saint Bartholomew's Society of Providence shall furnish to the City and file with the City Clerk, prior to the erection of any of the foregoing, a Liability Insurance Policy Certificate, approved as to form by the City Solicitor, its limits to be not less than One Hundred Thousand (\$100,000) Dollars, indemnifying the City against any claims arising out of any damage due to the erection, maintenance and/or removal of any decorations or parts thereof.


