No. 55 AN ORDINANCE

IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1983-4 OF THE ORDINANCE OF THE CITY OF PROVIDENCE APPROVED FEBRUARY 18, 1983 AND ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE SILVER LAKE REVITALIZATION PROJECT" FOR THE ACQUISITION OF LOT 161 ON PLAT 110, 692 PLAINFIELD ST.

Approved February 14, 2003

Be it ordained by the City of Providence:

- 1. That Chapter 1983-4 of the Ordinances of the City of Providence, approved February 18, 1983 and entitled, "An Ordinance Approving and adopting the Official Redevelopment Plan for the Silver Lake Revitalization Project", as amended, by the following Ordinances of the City of Providence: Chapter 1984-21, approved March 23, 1984, Chapter 1987-9, approved March 11, 1987, Chapter 1992-47, approved November 25, 1992, Chapter 1995-12, approved June 9, 1995, Chapter 1997-11, approved February 23, 1997, and Chapter 1997-45, approved September 11, 1997, is hereby further amended as follows:

A. To the list of designated properties for acquisition in Section 2, entitled, "Proposed Acquisition" under Chapter E, entitled, "Plan Proposals" contained and set forth on Page 19 of that certain booklet entitled "Silver Lake Revitalization Project, Official Redevelopment Plan, 1983", which is a part of the aforementioned Ordinance, the following properties shall be added:

Table with 2 columns: PLAT / LOT and ADDRESS. Row 1: 110/ 161, 692 Plainfield st.

B. Certain Maps of the Official Redevelopment Plan herein identified, Proposed Acquisition and Disposition shall be amended to include the Proposed Acquisition of the aforementioned lots.

- 2. That said Chapter 1983-4 of the Ordinances of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.
3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.


