AND BE IT FURTHER RESOLVED, That the City Council requests the Mayor to recommend that the Ordinance establishing a 56 hour week in the Fire Department be changed to a 48 hour week commencing October 1, 1961.

AND BE IT FURTHER RESOLVED, That the next budget include sufficient funds to increase uniform allowances to \$100.00 annually for policemen, and \$50.00 for firemen.




MEMBER OF BOARD OF CANVASSERS AND REGISTRATION
