

# RESOLUTION OF THE CITY COUNCIL

No. 581

Approved December 11, 1990

Whereas, the property shown on Assessor's Plat 99 Lot 138, bounded by Anchor Street, Glasgow Street, Corina Street, Fernando Street, Virginia Lane, Lancashire Street, Cornwall Street, Sherwood Street and the Louisquisett Pike and containing approximately one million, thirty three thousand six hundred forty three (1,033,643) square feet and has limited use for municipal purposes;

Whereas, this parcel of land could be disposed of by the Providence Redevelopment Agency for purposes beneficial to the area which would result in a profit for the City;

NOW THEREFORE, BE IT RESOLVED, that His Honor the Mayor convey to the Providence Redevelopment Agency the above mentioned lot for the sum of one dollar (\$1.00). This transfer is contingent upon the following conditions:

1. The Providence Redevelopment Agency shall see that said parcel is developed in accordance with the Comprehensive Plan and the City Zoning Ordinance;
2. That the portion of the site that has been developed as Corliss Park be transferred to the Parks Department by the Providence Redevelopment Agency;
3. That the portion of the site, necessary for the operation of the Rhode Island School for the Deaf, be transferred to the School for the sum of one dollar (\$1.00);
4. That all proceeds from the sale of the remaining portion of the site, minus administrative and development costs, shall be returned to the City of Providence.

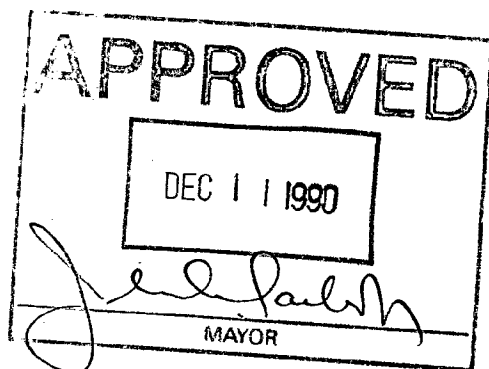

We would appreciate it if the aforesaid resolution is placed on the docket for the next City Council meeting.

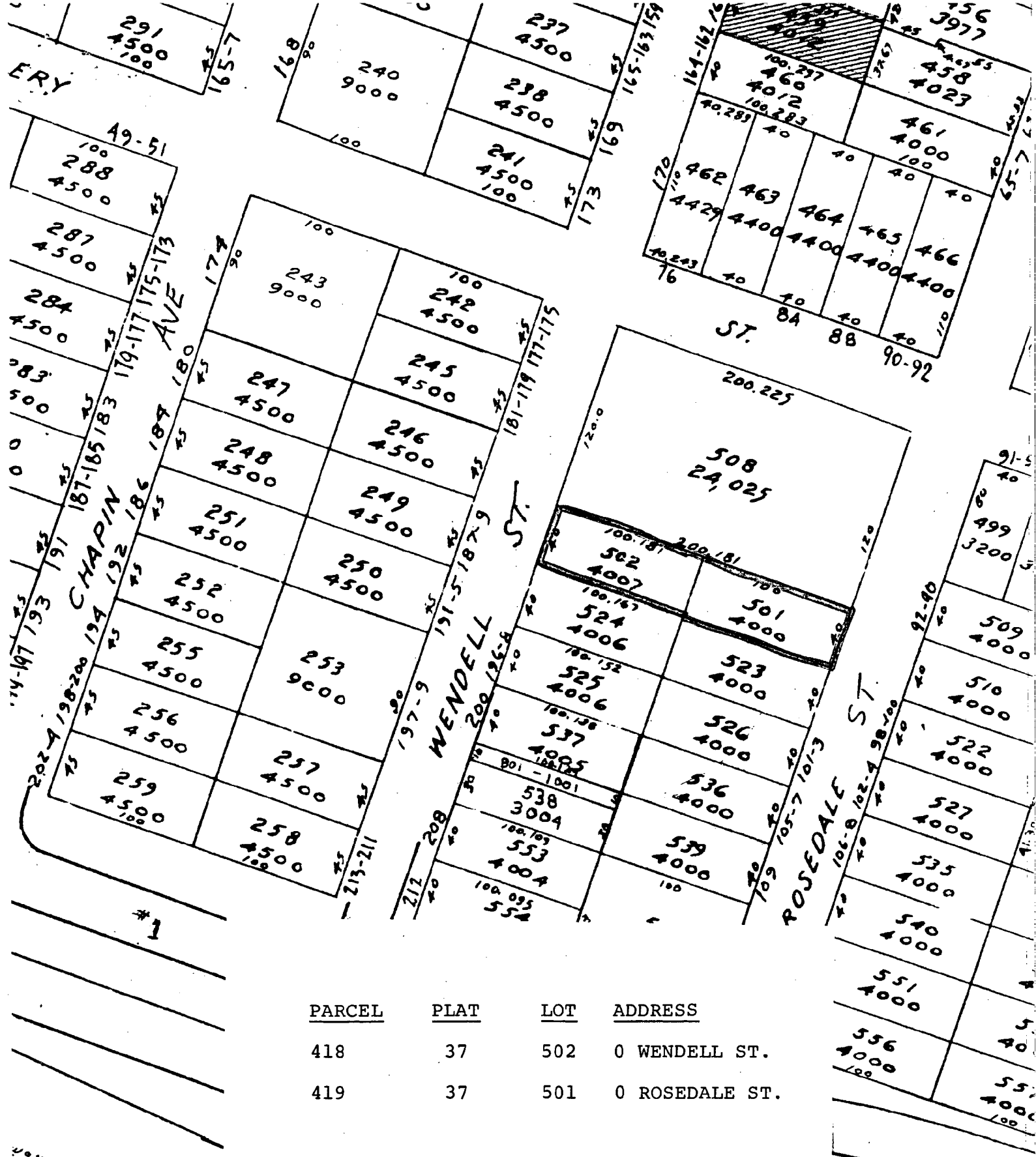

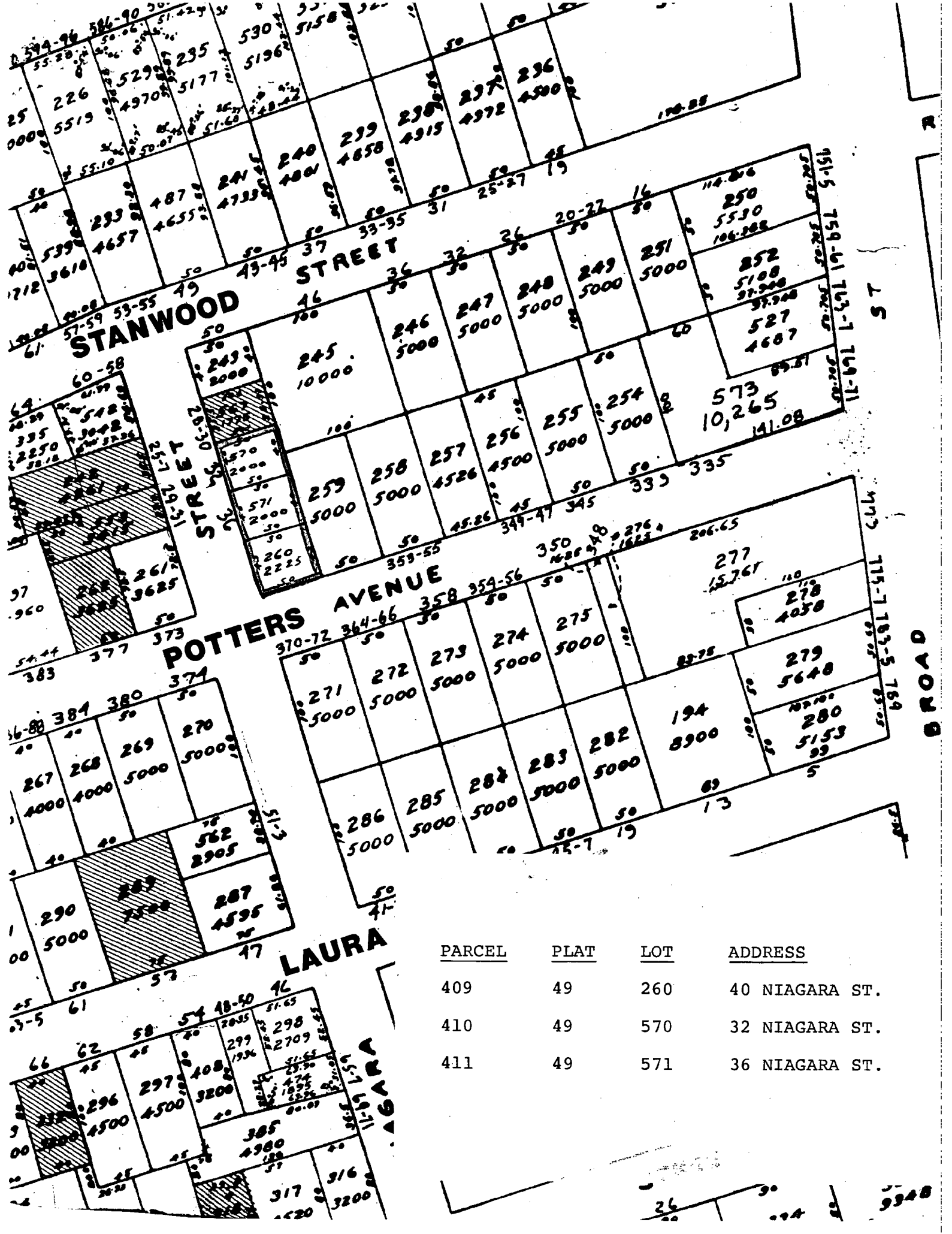


PARCEL	PLAT	LOT	ADDRESS
