RESOLUTION OF THE CITY COUNCIL

Approved September 5, 1958

Resolved,

That the City Treasurer, acting under the direction of the Committee on Finance, be and hereby is authorized and directed to borrow from time to time, in such sums as may be necessary, not exceeding EIGHTY THOUSAND (\$80,000) DOLLARS, in accordance with the provisions of Sections 41, 43 and 92 of Chapter 3654 of the Public Laws of Rhode Island, 1956, entitled, "REDEVELOPMENT ACT OF 1956", and to issue the City's notes therefor, signed by him and countersigned by the Mayor and Chairman of the Committee on Finance, and to renew any such notes from time to time as the same become due. The money thus obtained shall be used exclusively for carrying out the purposes of a loan and grant contract between the Providence Redevelopment Agency and the Housing and Home Finance Agency of the United States of America for financing the new Redevelopment Plan for the Point Street Area.

AND BE IT FURTHER RESOLVED, THAT the City Treasurer of the City of Providence is hereby authorized upon approval by the Finance Committee of the City Council of the City of Providence to pay over to the Providence Redevelopment Agency, "Projects Expenditures Account," Project No. UR RI 1-1, as an interim cash local grant-in-aid of the Project, so much of said sum as may be required by said Redevelopment Agency from time to time, for the purposes aforesaid.
