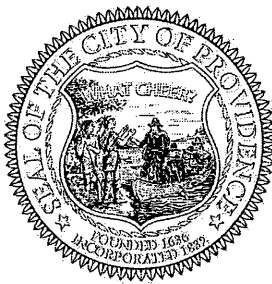



WHEREAS, Each September, Deaf Awareness Month is celebrated to raise awareness of the issues faced by the deaf and hard of hearing, and to provide an opportunity to recognize, honor and learn more about the contributions they have made to our state; and

WHEREAS, The Providence City Council urge all our residents to take the time to get a better understanding of the culture and needs of our deaf and hard of hearing residents and to commit to doing all we can to ensure them a high quality of life in our city and state.


