CHAPTER 1344

No. 347 AN ORDINANCE IN AMENDMENT OF CHAPTER 544 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, APPROVED SEPTEMBER 21, 1951, AS HERETOFORE AMENDED, IS HEREBY FURTHER AMENDED BY CHANGING FROM AN R-3 GENERAL RESIDENCE ZONE TO A C-2 GENERAL COMMERCIAL ZONE LOT 143 AS SET OUT AND DELINEATED ON CITY ASSESSOR'S PLAT 110; SAID LOT BEING LOCATED WITHIN THAT AREA BOUNDED BY THE EASTERLY LINE OF BRONX STREET AND THE WESTERLY LINE OF EAST PARK STREET.

Approved August 5, 1960.

Be it ordained by the City of Providence:

SECTION 1. The Zoning Map accompanying and made a part of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, as heretofore amended and entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations", is hereby further amended by changing from an R-3 General Residence Zone to a C-2 General Commercial Zone Lot 143 as set out and delineated on City Assessor's Plat 110; said lot being located within that area bounded by the easterly line of Bronx Street and the westerly line of East Park Street, bounded and described as follows:

Beginning at the northwesterly corner of East Park and Murray Streets; thence in a general northerly direction along the general westerly line of East Park Street to its intersection with the general easterly line of Bronx Street; thence in a general southerly direction along the general easterly line of Bronx Street to the northwesterly corner of Murray and East Park Streets and the point and place of beginning. Said parcel being a portion of Lot 143 as shown on Assessor's Plat 110.

SEC. 2. This Ordinance shall take effect upon its passage.



The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, February 9, 1960.

This referral is a request to change from an R-3 General Residence Zone to a C-2 General Commercial Zone Lot 143 on Assessor's Plat 110 being identified as "Silver Lake Basin Plat". The area in question contains 137,949 square feet.

On the field trip it was found that the area in question is the present Silver Lake Basin, better known as the Silver Lake Dump. The area is a vacant tract of land and the area surrounding the Basin is predominantly vacant.

As the area stands today, it serves no useful purpose. Therefore, if this petition were granted it would increase the value of the area in question through the development of the land and the surrounding area.


Dear Mr. Brock:

The Providence Redevelopment Agency acknowledges your request of February 24, 1960 for a report on the petition for a change in zone of the so-called "Silver Lake Basin Plat", specifically Lot 143 on Assessor's Plat No. 110 insofar as it pertains to an area designated by the City Council as Redevelopment Area A-2.

This Agency as late as 1959 has reviewed the subject site for its possible use for relocation housing. A requested report from the Federal Housing Administration as to its feasibility was received which presented a negative result. This was based primarily upon the underlying sub soil conditions which would present a too great a risk of insurability. For this reason further consideration for use of this area was dropped.

Present plans and those that can be projected into the next ten years do not include any proposed activity in the project area. There are many other areas of the City that are in need of remedial action with greater marketability potential than the Silver Lake Basin area. For these reasons it is reasonable to assume that the Providence Redevelopment Agency does not contemplate any plans of redevelopment in this area.

Gentlemen:

With your kind permission I wish to offer to you a favorable recommendation with respect to the re-zoning of the Silver Lake basin, a matter now pending before you.

This property prior to the present petition was offered for sale to the Providence Redevelopment Agency for the purpose of constructing relocation housing, presumably Section 221 housing for persons displaced from their homes by public improvement projects. The Agency was definitely interested in the proposal but I am informed, dropped the matter after discussions with F.H.A. indicated the site and terrain to be so difficult that it could not be approved for a construction loan.

This indicates the area is for all practical purposes unsuited for housing. Neither is it desirable that it be left in its existing condition. It was the experience of our minimum housing inspectors covering this area that the basin was a constant source of complaint, particularly from the viewpoint of rodent infestation.

I believe the proposed use of this location as a super-market will afford the best--perhaps the only--practical use of this property and would not depreciate nearby properties--indeed in view of existing conditions here--such a use would in my opinion definitely improve the environment. Add to this consideration the taxable value which effectuation of the proposal would create, and its approval appears even more desirable.






