

Re: Petition to abandon Prescott Street


Dear Sirs:

The Narragansett Electric Company presently has overhead electrical facilities consisting of a pole, transformers, cables and wires located on said Prescott Street. These facilities are an important electric supply system to this area and would be very difficult and costly to relocate as they supply the petitioner and possibly could serve customers of Narragansett.

However, The Narragansett Electric Company will not object to the granting of said petition, provided that in the event the petition is granted, the Petitioner will convey easements acceptable to The Narragansett Electric Company which will permit the retention of our facilities in existing locations on said street, together with the right to inspect, maintain, operate and replace the same.

Subject: Referral No. 2011 Abandonment of Portion of Prescott Street

Gentlemen:

The subject petition from the Committee on Public Works proposed the abandonment of Portion of Prescott Street from Robin Street to the westerly side lot line of Lot 28 on Assessor's Plat 66. This petition was requested by Norman Saucier, owner of the properties on the entire northerly side of aforesaid portion of Prescott Street.

A field inspection revealed that the aforesaid portion of Prescott Street is an asphalt paved street without curbstones and is located within the M-1 Zone with an industrial use at the northerly side and vacant lots at the southerly side.

Since Holyoke Street has been abandoned, and if the aforesaid portion of Prescott Street is abandoned, Lot 228 at 77 Prescott Street will become a semi-landlocked parcel and a dead-end Prescott Street will also be recreated. Therefore,
