



SUBJECT: CCR # 581 -- Barrier on Dodge Street

A meeting was held by James T. Morris with a Mary Ellen Medeiros of Wiggins Village. At that meeting, an area on Bridgham Street, NOT Dodge Street, was shown to Mr. Morris for a requested erection of a barrier.

The area along Bridgham St. on the northerly side, west of the intersections of Central and Dodge Sts. could not be defined as to the exact location for placement of said barrier.

~~Mrs. Medeiros explained to Mr. Morris that cars traveling in an~~
easterly direction were crossing the westerly travel line when being chased by police and crashing into the apartments. Mr. Morris explained to her that at any point along Bridgham Street, this could occur. Mr. Morris suggested that a chain-link fence be erected along the entire property line on Bridgham Street.

Therefore, a barrier is NOT feasible due to the length, over 250ft of requested protection.
