PRESENTATION OF EMERGENCY ORDINANCE

COUNCIL PRESIDENT HAXTON, COUNCILMAN FLYNN, COUNCILMAN GARAN, COUNCILMAN McKIERNAN, COUNCILMAN XAVIER, COUNCILMAN CIRELLI and COUNCILMAN JOHNSON:

An Emergency Ordinance Relative to the Issuance of Permission to Erect, Alter or Use a Building or Structure at the Location Named Herein for Sale of Petroleum, Kerosene, Gasoline, Coal Oil and Their Products, Compounds and Components.
