Resolution Declaring the Month of June to be National Pride Month.

WHEREAS, June is Pride month, a time to celebrate and affirm that lesbian, gay, bisexual, transgender, queer, intersex, and asexual (LGBTQIA) rights are human rights; and

WHEREAS, The origin of Pride is the Stonewall Uprising of 1969, in which LGBTQIA community members affirmed their right to live free of harassment, prejudice, and violence; and

WHEREAS, The Providence City Council affirms the right of all residents to live and work in a safe and inclusive community free from discrimination; and

WHEREAS, Discrimination, bullying, violence, and a lack of acceptance continues to contribute to higher rates of school dropouts, youth homelessness, and ongoing mental health challenges for LGBTQIA youth; and

WHEREAS, Adult members of the LGBTQIA community continue to face discrimination, inequity in opportunity, and violence, simply for expressing their full humanity, and this is especially true for trans women and trans women of color; and

WHEREAS, Education regarding LGBTQIA issues supported by a legal framework that outlaws discrimination in employment, housing, financial transactions, and other services is important to help increase safety and respect for LGBTQIA members.

NOW, THEREFORE, BE IT RESOLVED, That Providence City Council welcomes June as Pride month as a celebration of LGBTQIA members and a call to action to expand equity, diversity, community safety for all residents.

BE IT FURTHER RESOLVED, That Providence City Council celebrates and recognizes the contributions, struggles, risks, and many identities of Providence's LGBTQIA community and their families and proudly affirms that love is love.

BE IT FURTHER RESOLVED, That the Providence City Council hereby recognizes June as Pride Month in perpetuity.

BE IT FURTHER RESOLVED, That Providence City Council wishes the LGBTQIA community and straight allies a very happy Pride month, and encourages safe celebrations.

Resolution Engaging Steve Smith of Steve Smith Consulting, LLC as a consultant to the City Council.

WHEREAS, This resolution is authorizing the City Council President to engage Steve Smith of Steve Smith Consulting, LLC, at a cost of no more than five thousand (\$5,000.00) dollars a month not to exceed sixty thousand (\$60,000.00) dollars annually, to provide education policy advice and guidance as it relates to the return of the Providence Public School system back to local control; and

WHEREAS, Steve Smith has over forty years of education experience in Rhode Island including his time as a teacher and as the President of the local chapter of the American Federation of Teachers. Steve also brings twenty years of experience as a State Representative and a unique understanding of legislative processes at both the state and local levels; and

WHEREAS, Section 401 (D) of the City's Home Rule Charter authorizes the City Council "To retain by majority vote of the entire city council and to fix the salaries of those consultants it deems necessary for the exercise of its functions including, but not limited to accountants, engineers, and other experts not regularly employed in any city department or service. The city council shall have the power to appropriate funds to defray the costs thereof"; and

WHEREAS, It would be extremely beneficial to have a consultant on call to advise and support the City Council in the work to return the Providence Public School system back to local control.

NOW, THEREFORE, BE IT RESOLVED, That pursuant to Section 401 (d) of the Providence Home Rule Charter, the City Council of the City of Providence hereby authorizes the City Council President to sign an agreement with Steve Smith of Steve Smith Consulting, LLC to provide education policy advice and guidance as it relates to the return of the Providence Public School system back to local control.

COUNCILMAN GONCALVES

Resolution Opposing the Designation of the Director of the Rhode Island Department of Transportation as the Board Chair of the Rhode Island Public Transit Authority.

WHEREAS, The Rhode Island Public Transit Authority (RIPTA) plays a crucial role in providing accessible and efficient public transportation services to the residents of Rhode Island; and

WHEREAS, The proposed Senate bill sponsored by Senate President Dominick Ruggerio seeks to add an additional member to the RIPTA Board of Directors and designate the Director of the Rhode Island Department of Transportation (RIDOT) as the board's chair; and

WHEREAS, This proposed change would result in the automatic demotion of the current board chair, who was appointed based on their qualifications and experience; and

WHEREAS, It is crucial for RIPTA to maintain its independence in order to make decisions that prioritize the needs of public transportation users and the communities it serves; and

WHEREAS, The changes being proposed may cause a disturbance in the current balance of expertise and perspectives on the board, which could potentially harm the efficient governance and decision-making process of RIPTA.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby opposes the designation of the Director of RIDOT as RIPTA’s board chair.

Resolution Affirming Providence's commitment to inclusivity of the Non-Binary Gender Community and promising the introduction and implementation of an ordinance for mandatory Gender-Neutral Bathrooms in all public buildings.

WHEREAS, The City of Providence and the Providence City Council acknowledges the inherent worth of all its residents, dignity and humanity irrespective of their sexual orientation, gender identity or expression; and

WHEREAS, The City of Providence and the Providence City Council is committed to upholding the principles of diversity, equality, and inclusivity, thereby ensuring an environment where everyone is heard, seen, respected, safe, and free from prejudice and discrimination; and

WHEREAS, Access to public restrooms can pose significant challenges and risks for individuals who identify as non-binary, lesbian, gay, bisexual, transgender, queer or questioning, intersex, asexual, two-spirit, plus (LGBTQIA2S+); and

WHEREAS, The Providence City Council recognizes the need for change to improve the inclusivity and accessibility of our public spaces for all residents, including those who identify as LGBTQIA2S+; and

WHEREAS, The provision of at least one gender-neutral bathroom in all public buildings is one step towards making our city a more inclusive, safe and welcoming place for every Providence citizen, regardless of gender identity or expression.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby affirms its steadfast commitment to the safety, inclusivity, and welcoming of gender-non binary and the LGBTQIA2S+ community within its jurisdiction.

BE IT FURTHER RESOLVED, That the Providence City Council pledges to draft and pass an ordinance mandating that every public building in the City of Providence includes at least one gender-neutral bathroom, or, at the very least, provides bathroom access according to each individual's self-identified gender identity.

BE IT FURTHER RESOLVED, All City departments and city agencies are directed to work cooperatively to ensure the swift and effective implementation of the proposed ordinance once enacted.

BE IT FURTHER RESOLVED, The City Council encourages institutions to follow this example of inclusivity and to consider the specific needs and rights of the non-binary and/or LGBTQIA2S+ community in their policies and practices.
