Beginning at the northwesterly intersection of Eddy Street and Aldrich Street, thence westerly along the northerly line of Aldrich Street, bounded northerly by Lots 169, 168, 166, 165, 164, 162 and 10, to the southwesterly corner of lot 10 on City of Providence, Assessor's Plat 57, thence northwesterly, bounded westerly by lot 161, to the northwesterly corner of lot 10; thence easterly along the northerly lot lines of lots 10, 162, and 164 to the northeasterly corner of lot 164; thence westerly to the northwesterly corner of lot 165; thence easterly along the northerly lot line of lot 165 to the northeasterly corner of lot 165; thence southeasterly to the northwesterly corner of lot

166; thence easterly along the northerly lot lines of lots 166, 168, 169 to the westerly line of Eddy Street and the northwesterly corner of lot 169; thence southerly along the westerly line of Eddy Street to the northwesterly intersection of Eddy Street and Aldrich Street; said point being point and place of beginning.

Section 2. This Ordinance shall take effect upon its passagae.

Resolution Requesting the City Solicitor to Prepare, Cause to be Introduced and to Urge Passage at the 1981 Session of the General Assembly of the State of Rhode Island, of "An Act for Immediate Consideration for Enactment of Enabling Legislation to Implement a Public Safety Fee in the City of Providence".

Referred to Committee on Finance, on motion of COUNCILMAN SALVATORE, seconded by COUNCILMAN GLAVIN.

The motion to Refer is Sustained.

**COUNCIL PRESIDENT PRO TEMPORE
STRAVATO:**

Resolution Requesting the Auditor General of the State of Rhode Island to Immediately Proceed to Investigate the City of Providence's present Fiscal Situation and report its Findings to the City Council along with Recommendations as to what Steps this Body can take to Alleviate the City's Fiscal Crisis.

Whereas, The City Council of the City of Providence over the last several years has been attempting to bring to the attention of the present administration that it was spending city revenues at a rate which far exceeded its actual or reasonable expected revenues, but to no avail, and

Whereas, The City Council of the City of Providence as recently as June, 1980 again attempted to bring to the present administration's attention its irresponsible spending practices, but again to no avail, and

Whereas, The City is presently facing a deficit for fiscal year 1981 in excess of Twenty-Four

Million Dollars (\$24,000,000.00) and an overall deficit in excess of Thirty-Five Million Dollars (\$35,000,000.00) due to the irresponsible manner in which the present administration has addressed the City's fiscal needs.

Now, Therefore, Be It Resolved, That the City Council of the City of Providence respectfully requests that the Auditor General of the State of Rhode Island immediately proceed to investigate the City's present fiscal situation and report its findings to this body along with recommendations as to what steps this body can take to alleviate the City's fiscal crisis.

COUNCILMAN ADDISON moves passage of the Resolution.

This motion is seconded by COUNCILMAN GLAVIN.

COUNCILMAN MANSOLILLO moves the following amendment be incorporated in the Resolution following the third paragraph:

"Whereas, The City Council failed on a number of occasions to approve budgets submitted by the Mayor, and

Whereas, The City Council of Providence failed to offer for sale surplus property, and

Whereas, This City Council was complicit in preventing the Public Utilities Commission from raising water rates,"

This motion being seconded by COUNCILMAN PEARLMAN and COUNCILMAN GRIFFIN is Put to Vote and Not Passed.

COUNCILMEN MANSOLILLO, ALMAGO, PEARLMAN and SNOWDEN desire to be recorded as voting "No" on the motion for passage of the foregoing Resolution.

The motion for Passage is Thereupon Sustained.

PERSONAL PRIVILEGE

COUNCILMAN JOHNSON requests and is granted the Privilege of the Floor and states:

In the course of the announcement of our tax deficit accrued at the Council Meetings, it has been suggested that there are solutions to our particular problems. All of us have had a lot of ideas about it and at this time, I would like to announce an idea that I've had. Not so much that I think its a better idea than some of the others that have been brought forth, but I think it has some credibility along the long line so it doesn't effect the people in any way whatsoever, it does not in any way hurt the people of Providence and what I am suggesting might sound very, very radical, is to have the Water Supply Board go public and sell debentures.

Now, this is something that I have investigated with the Public Security and Exchange Commission. As a matter of fact, I talked with Mr. Willard Riccio who is in charge of the Public Security and

Exchange Commission in Boston of this year and the way this would be done would be the sale of debentures and these debentures, what we would do, would be to set up a private firm, call up departments, Water Supply Board, and have a total entity of its own. Now, what makes that relatively new?

Well, the fact is by sale of these bonds, we could solve our particular financial crisis. Again, the individuals that purchase these bonds would be receiving tax exempt payments, that's the people who go to the banks with their coupons, and it is a feasible way.

I would like anyone to get together with me on this here and naturally I believe that a number of heads stick together and we'll work this out and probably get a speedy package in case it can be worked out, and it is something for everyone to consider and I would appreciate anyone that would like to get together with me on this particular motion.
