"Mr. President, there is a problem in the School Department regarding the Bus Passes. The system is awarding the bus passes and right now, today, we have children who have approved bus passes but they are not being issued on time. Basically, the bus passes for the month of October are yet to come out and when it happens, the child will get on a bus to go home and they have a pass that has expired. The passes now will say September and because it is believed they have expired, they confiscate the pass.

If it costs a child at least \$2.00 a day depending on where they are going to school then that is an expense that is unnecessary. So, what we need to do we could possibly bid by the Board of Contract or get a contract with a bus company they would be getting their money on time and the studetns would be better off. This thing is happening every month because the passes are not being issued on time and maybe we should have a meeting with Dr. Zarella and whoever else would be involved to change this process and this system and get the bus passes out and issued on time.

Many of these kids do not have \$2.00 a day

for a bus pass and this could be a serious problem. This could be a serious problem regardless of the magnitude of it. This should be addressed and this problem that our schools are having. Point two, we had a meeting here regarding the Charter Amendment on the Referendum amending the Charter regarding the Retirement Board membership and I would hope that the efforts that were discussed between the the parties are being discussed and that changes are being made. Also

the Investments and how they are being made were also discussed and I would hope that this is also being looked into. We were supposed to sit down with the Retirement Board and this has not happened yet and I feel this is not being looked into then these matters be placed on the ballot. Thank you, Mr. President".

Alternatively, Petitioner shall grant to the City an easement suitable for full sewer maintenance. Such easement shall be satisfactory to the City Solicitor.

(3) Petitioner shall reimburse the Providence Water Supply Board for (a) the estimated value of the remaining useful life of the abandoned main and hydrant; (b) the cost of severing and capping the main at the modified northern limit of Atkins Street; and (c) the cost of installation of a new fire hydrant assembly. Reference is specifically made to letter dated 30 September 1993 from the Providence Water Supply Board.

(4) The City reserves for the benefit of New England Telephone and Telegraph Company and its successors and transferees an easement permitting New England Telephone and Telegraph Company to retain its facilities located in the abandoned portion of Atkins Street and further for the inspection, maintenance operation and replacement of the same. Access shall be twenty-four hours daily. Alternatively, the Petitioner shall grant to New England Telephone and Telegraph Company easements of like import. Such easements shall be acceptable to New England Telephone and Telegraph Company. (See Attachment "B").

(5) The petitioner shall convey and easement acceptable to the Naragansett Electric Company which will permit retention of its facilities in their existing location, together with the right of inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation. (6) The City recognizes that the abandonment would have the effect of landlocking and abutting parcel. Representations of a sale to be effected have been presented to the City.
