

Department Engineering Office, Street Line Section, having ceased to be useful to the public and the same is abandoned as a public highway, and the damage to the abutters is appraised at nothing and so awarded, and it is further

Dear Councilman Payne:

Under date of May 6, we received a memorandum from the Department of the City Clerk regarding the proposed abandonment of a portion of Cass Street as a public highway. A few weeks ago, we received a call from the attorney for Federal Products, Mr. Wilfred E. McKenna, and we explained to him that if the Providence City Council acted favorably upon the abandonment of this highway, they would have to pay the depreciated value of the facilities of the Water Supply Board in this street.

Under the circumstances, we computed the depreciated value of the water main and valves and services and informed him that the cost would be \$3,544.86. We have also discussed the matter with the Plant Engineer for Federal Products and he is aware that the company will have to pay the charges previously referred to.

We are making out a bill to Federal Products in the amount of \$3,544.86 and respectfully request that any action taken by your Committee will be dependent upon the payment of this sum to the department.




The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, May 28, 1968.

RE: PETITION TO ABANDON A PORTION  
OF CASS STREET

In reply to the Memo of June 4, 1968 sent to me by Vincent Vespia, City Clerk, with respect to the abandonment of the above street, I refer you to Section 24-6-1 of the General Laws, Rhode Island, 1956, as amended, and the following sections which govern the procedure to be used by the City in abandoning any public highway.


This section and the following sections indicate that it is a purely legislative act whenever the City desires to abandon a particular highway, or portion thereof.

It must first be determined by the Council, after a hearing, that the particular highway in question has ceased to be useful to the public. Notice of this hearing must be furnished to abutting landowners and damages, if any, that may be incurred by them must be assessed at this hearing.

It would be the responsibility of the City to pay the abutting landowners for damages, if there are any, and I would therefore recommend before action is taken on any petition to abandon any highway or portion thereof, that serious consideration should be given as to its effect upon abutting landowners and whether or not they would incur damages if the Council acted to abandon the particular street in question. Notice of the action of the Council must be given to the owners of record within the state.

If the Committee has, after a hearing on the above matter, determined that the portion of Cass Street to be abandoned has ceased to be useful to the public, and if the Committee is satisfied that there will be no damages incurred by abutting landowners, then I see no objection to favorable action by the Council on this petition.



I believe you have in your files a letter from them stating their reasons.

Mrs. Clayton Morse, who resides at 246 O'Connor Street, and who owns property on Cass Street under the name of Streeter, feels that the abandonment of the street will devalue the property substantially.
