TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body

June 12, 1980

Dear Sirs:

We seek permission to change the name of Lonsdale Street, which runs between North Main and Canal Streets, to Park Row for the following reasons:

1. To avoid confusion with Lonsdale Avenue. The main entrance to the only building on Lonsdale Street (currently known as 128 North Main Street) will be moved to Lonsdale Street and the building must be easily located and identified by its tenants and their clients.
2. Park Row better describes the street's location next to the Roger Williams National Monument.
3. The street is not numbered. By identifying a major office building as "One Park Row", the viability of the surrounding commercial and residential neighborhood is enhanced. We are renovating the major building in the area and focussing its entrance toward the park and the emerging historic district. We feel that the street name should reflect the character of its environs.
4. Our building is the only one on the street and there should be no opposition to the name change.


