No. 510 AN ORDINANCE REQUESTING THE SECRETARY OF STATE TO SUBMIT THE FOLLOWING QUESTIONS TO THE VOTERS AT THE GENERAL ELECTION TO BE HELD ON THE TUESDAY, NEXT AFTER THE FIRST MONDAY IN NOVEMBER, A. D. 1962.

Approved September 21, 1962

Be it ordained by the City of Providence:

Section 1. The Secretary of State is hereby requested to submit the following questions to the qualified electors of the City of Providence at the General election to be held in said City on the Tuesday next after the first Monday in November, A. D. 1962, namely:

- (1) Shall Chapter 185 of the Public Laws of Rhode Island 1962 be approved and the City of Providence be authorized to issue bonds in a sum not exceeding Seven Million Five Hundred Thousand (\$7,500,000.00) Dollars for school purposes, as provided in said Act?
- (2) Shall Chapter 177 of the Public Laws of Rhode Island 1962 be approved and the City of Providence be authorized to issue bonds in a sum not exceeding One Million Seven Hundred Fifty Thousand (\$1,750,000.00) Dollars for school purposes, as provided in said Act?
- (3) Shall the City of Providence be authorized to issue bonds in a sum not exceeding One Million (\$1,000,000.00) Dollars for the construction of a sludge incinerator and facilities incidental thereto?

Sec. 2. The City Clerk is directed to transmit to the Secretary of State forthwith upon the passage of this Ordinance, a certified copy thereof.

Sec. 3. This Ordinance shall take effect upon its passage and all Ordinances and Resolutions and parts of either inconsistent herewith are hereby repealed.

Dear Councilman Matera:

Under date of November 3, 1961, we received an official memorandum from the City Clerk's Office entitled Abandonment of a Portion of Dorrance Street and Dyer Street. This was similar to a memorandum received on May 20, 1960. On May 25, 1960, we replied as follows:

Regarding the proposed abandonment of Dorrance Street from the easterly line of Dyer Street easterly to its termination as shown on the attached plan area A - B - C - D - A, we have a 6-inch water main laid in 1890, two 4-inch services installed in 1890, a post hydrant installed March 10, 1958, and a 3/4-inch copper service installed November 12, 1957. If this section of Dorrance Street is to be abandoned, the petitioner must reimburse this department for the depreciated value of the following facilities:

153.51 feet of 6-inch cast iron main laid in 1890	\$684.96
2 - 4" cast iron services installed in 1890	430.45
1 post hydrant installed March 10, 1958	398.63
1 - 3/4" copper service installed November 12, 1957	<u>69.62</u>

Total depreciated value \$1,583.66

The 3/4" copper service referred to above was installed in 1957 under an application made by the Rhode Island State Department of Public Works. It is used for watering a section of the grassed area of the North-South Freeway and if the water main is to be abandoned in this section of Dorrance Street, the State will be deprived of this facility.

Regarding the proposed abandonment of Dyer Street from a point square opposite the northeasterly corner of Dorrance Street southerly a distance of 90 ft., more or less, we object strenuously to this abandonment. We have shown this area in red on the enclosed map and it is bounded by A-D-E-F-A. In this section we have a 24-inch and 30-inch feeder main, a 16-inch special

fire supply and an 8-inch rider main. If these mains have to be relocated, it will cost the department \$15,000-\$20,000 and it will be necessary to tear up sections of the new freeway. In the meantime, while these operations are taking place, Narragansett Electric, the Davol Rubber Company, Brown University and large areas of the East Side will be deprived of a water supply.

Under the circumstances, this department recommends against the abandonment of that section of Dyer Street called for in the petition.

SUBJECT: Abandonment of Portion of Dorrance Street and Dyer Street


Gentlemen:

The portion of Dorrance Street, from the easterly line of Dyer Street to its easterly termination, and the portion of Dyer Street, from a point opposite the northeast corner of Dorrance Street and Dyer Street southerly for a distance of 90 feet more or less, serve no useful purpose other than as a means of access to the Gammino Building at 200 Dyer Street and the parking lot that has been created in the area adjacent to and under the Providence River Bridge approaches.

If these portions of the two streets were to be abandoned, there would be no substantial change in the access available to these properties under the present manner in which they are being used. In addition, a substantial amount of land would be made available for off-street parking purposes.

From a traffic movement standpoint, it is therefore recommended that these portions of Dorrance Street and Dyer Street be abandoned.

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, November 21, 1961.

This referral is a request for a study, report and recommendation concerning the proposed abandonment as a public highway that portion of Dorrance Street from the easterly line of Dyer Street to its easterly termination and also the abandonment of Dyer Street from a point square opposite the northeasterly corner of Dorrance Street and Dyer Street southerly a distance of ninety feet more or less.



This section of Dorrance Street has not been used for several years and probably would not be used for highway purposes in the future. It is now being used as a parking area.

However, two large Storm Sewers and two Gates are located in the street, which are a necessary part of our sewer system. The gates are inspected regularly and it is important that they be accessible at all times.

If the abandonment of the street is to be approved, the interests of the City should be protected by obtaining agreements with the parties who would acquire the land, in which they agree not to build any structure over the sewers and also make the sewers and gates accessible for inspection and repairs.






The petitions for the abandonment of two abutting sections of Dyer Street include the area from the southerly line of Dorrance Street to a point 93.75 feet north of the north line of Dorrance Street.

The area proposed for abandonment is a public highway and used as such until the State of Rhode Island relocated Dyer Street in conjunction with the construction of the Freeway. This section of Dyer street extends to the southerly line of Dorrance Street. If Dorrance Street is abandoned from Dyer Street to its easterly termination, the area of Dyer Street proposed for abandonment would no longer be of use as a public highway.

However, a 74" Storm Sewer, 20" Sanitary Sewer, a Slot, Water Lines, and other Public Utilities are located in this section of Dyer Street and it does not appear feasible to relocate these utilities.

Consequently, if the proposed abandonment is to be approved, the City should obtain easements, covering the entire width of the street, from the abutting owners who will acquire the abandoned portion of the street. It is very important that no structure be built in this area and the various utilities remain accessible for inspection, repairs or replacement.

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, January 9, 1962.





WHEREAS, The Housing Authority of the City of Providence, Rhode Island and the Public Housing Administration have indicated a willingness to undertake the development of a program for the housing of such persons; and

WHEREAS, the application of The Housing Authority of the City of Providence, Rhode Island as required by said United States Housing Act, was heretofore approved by the City Council of the City of Providence on September 16, 1949;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Providence, as follows:

There still exists in the City of Providence a need for low-rent housing at rents within the means of low-income families, with more particular reference to elderly persons, including single elderly persons.
