RECORD

The Zoning Board of Review met this day at 11:00 a.m. as Per Section 91 of the Zoning Ordinance of the City of Providence for the purpose of organizing as authorized by an ACT 75H 6457, entitled AN ACT RELATING TO THE ZONING BOARD OF REVIEW OF THE CITY OF PROVIDENCE, passed by the General Assembly at the January Session, A.D. 1975, and approved by the Governor of the nineteenth day of May, A.D. 1975.
