

WHEREAS, LGBTQ individuals have made and continue to make important contributions to the culture, vitality, and overall well-being of our city, our state, and our nation; and

WHEREAS, LGBTQ people are our neighbors, colleagues, friends, family, and vital members of our community; and

WHEREAS, Sadly, throughout much of the history of the United States of America, those in non-heteronormative relationships have been marginalized, ostracized, and even criminalized, forcing countless LGBTQ Americans to hide their identities and live in fear; and

WHEREAS, LGBTQ people in the United States face disparities in employment, healthcare, education, and many other areas central to the pursuit of happiness; and

WHEREAS, LGBTQ youth are at increased risk of suicide, homelessness, and becoming victims of bullying and violence; and

WHEREAS, LGBTQ individuals, in particular transgender individuals, face a disproportionately high risk of becoming victims of violent hate crimes; and

WHEREAS, Despite hardship and marginalization, LGBTQ Americans continue to fight for equality, dignity, and respect, and have achieved significant milestones, ensuring that future generations will enjoy a more equitable and just society; and

WHEREAS, LGBTQ Pride is a movement that promotes LGBTQ self-affirmation, dignity, and equal rights; and

WHEREAS, Today, LGBTQ Pride events and celebrations are held in communities across the globe, increasing their visibility as social group, building a sense of community, and combatting both shame and social stigma against LGBTQ individuals; and


