RESOLVED, That the Traffic Engineer is hereby requested to prohibit motor vehicle traffic along Thayer Street, from Waterman Street south to George Street on Friday, April 27, 1984 from 6:30 o'clock A.M. to 7:00 o'clock P.M.; Meeting Street and Cushing Street, from Brook Street to Hope Street on Saturday, April 28, 1984 from 6:30 o'clock A.M. to 5:00 o'clock P.M.; and Charlesfield Street, from Brook Street to Hope Street, on Sunday, April 29, 1984 from 12:00 o'clock Noon to 7:00 o'clock P.M., to accommodate the 1984 Brown University East Campus Block Party.


On Friday 27 April I am requesting that Thayer Street be closed from Waterman Street south to George Street during the time period of 6:30 a.m. to 7:00 p.m. This would accommodate the anticipated heavy pedestrian traffic in the Hegeman/Caswell Courtyard area.

On Saturday 28 April I am requesting that Meeting Street and Cushing Street, from Brook Street to Hope Street be closed to traffic from 6:30 a.m. to 5:00 p.m. This would accommodate the pedestrian traffic for an outdoor concert at the Pembroke Field House.

On Sunday 29 April I am requesting that Charlesfield Street, from Brook Street to Hope Street be closed to traffic from 12:00 noon to 7:00 p.m. to accommodate the East Campus Block Party.
