No. 333 **AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1996-23 OF THE ORDINANCE OF THE CITY OF PROVIDENCE APPROVED MAY 23, 1996 AND ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN AND THE ATTACHED RESTRICTIONS FOR THE DOUGLAS AVENUE REVITALIZATION PROJECT" FOR ADDITIONAL ACQUISITION.

Approved June 10, 1998

Be it ordained by the City of Providence:

1. That Chapter 1996-23 of the Ordinances of the City of Providence, approved May 23, 1996 and entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan and the Attached Restrictions for the Douglas Avenue Revitalization Project" as amended by the following : Chapter 1997-7, approved February 26, 1997, is hereby amended as follows:
 - A. To the Douglas Avenue Redevelopment Ordinance, Section 6. C., the following parcel shall be immediately added to the list of properties to be acquired:

ADDRESS	PLAT	LOT	AREA
9-11 Goddard Street	68	371	1,856
 - B. A certain map of the aforementioned Official Redevelopment Plan herein after entitled " Acquisition Map" shall be amended to include the Proposed Acquisition of Lots 422 and 423 an Plat 68.
2. That said Chapter 1996-23 of the Ordinances of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.
3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.

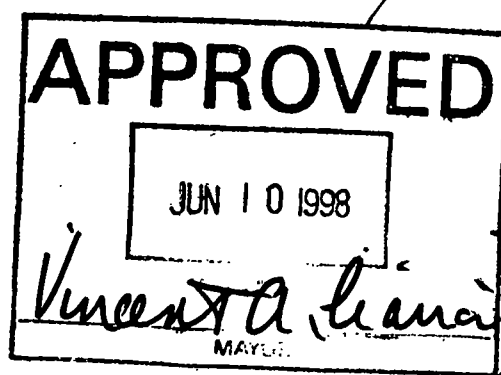

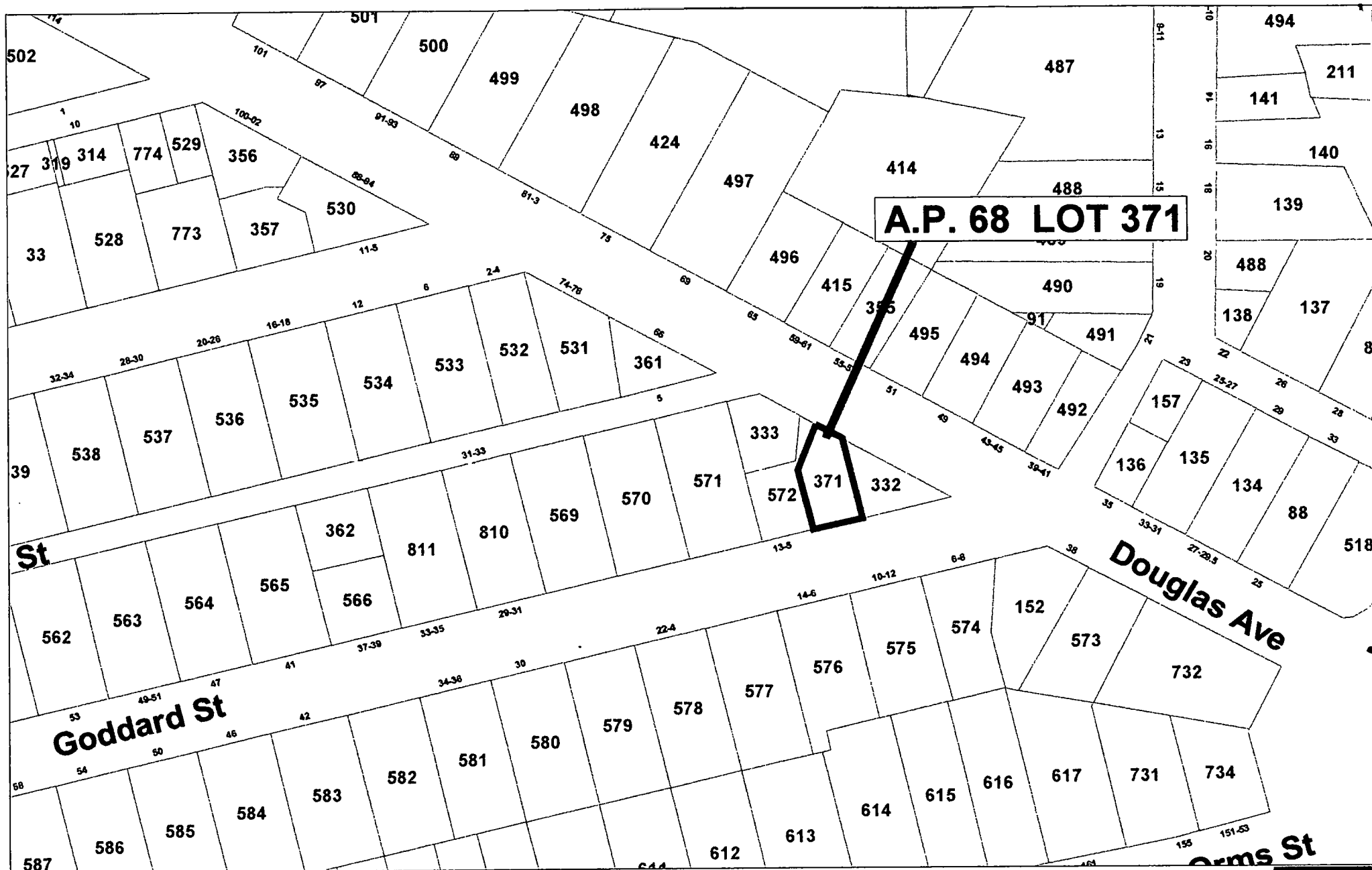
