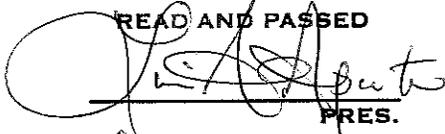

In accordance with Section 21-26 of the City's Code of Ordinances, I am writing to request that the following requested contract awards be submitted to the City Council and the Education Subcommittee for approval.

- *School Department* – Approval of payment in an amount not to exceed \$146,081 to Henry Barnard School at Rhode Island College for the tuition of ten (10) kindergarten students and twenty-nine (29) students in grades 1-5.

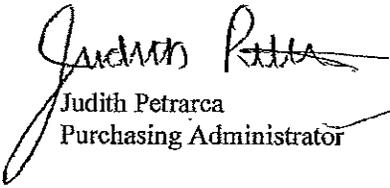
Dear Mayor Taveras:

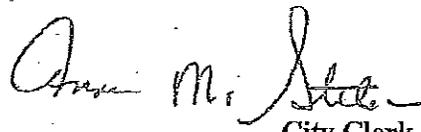
