No. 685 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1982-42, APPROVED JULY 7, 1982, BY TRANSFERRING CERTAIN SUMS OF MONEY FROM APPROPRIATION RESERVE, ITEM 3, TO MAYOR'S OFFICE, ITEMS 0 AND 1 AND CITY COUNCIL, ITEMS 0 AND 1.

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1982-42 of the Ordinances of the City of Providence, Approved July 7, 1982, Entitled: "An Ordinance making an Appropriation of One Hundred Fifty-Eight Million, Two Hundred Forty-One Thousand, Six Hundred Seventeen Dollars and Sixty-Nine Cents (\$158,241,617.69) for the Fiscal Year Ending June 30, 1983", is hereby amended as follows:

Transfer from Appropriation Reserve, Item 3 the sums of:

Eight Thousand, Seven Hundred Fifty (\$8,750.00) Dollars to Mayor's Office, Item 0,

Four Thousand (\$4,000.00) Dollars to Mayor's Office, Item 1,

Twenty-One Thousand, One Hundred Eighty-Seven Dollars and Eight Cents (\$21,187.08) to City Council, Item 0, and

Four Thousand, Five Hundred (\$4,500.00) Dollars to City Council, Item 1.

SECTION 2. This Ordinance shall take effect upon its Passage.
