Be it ordained by the City of Providence:

SECTION 1. Chapter 1976-36 of the ordinances of the City of Providence approved October 29, 1976, establishing a compensation plan for the City of Providence, is amended as follows:

Section 1.

Accountant II	Pay grade 12
Accountant III	Pay grade 14
Printer	Pay grade 16
Secretary of Director (Public Works)	Pay grade 14
Teller	Pay grade 10

SECTION 2. This ordinance shall take effect upon its passage and shall be retroactive to July 1, 1976.
