No. 665 AN ORDINANCE AMENDING CHAPTER 1343, SEC. 2 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, APPROVED AUGUST 5, 1960.

Approved December 26, 1967

Be it ordained by the City of Providence:

SECTION 1. Chapter 1343 Section 2 of the Ordinances of the City of Providence, Approved August 5, 1960 is hereby amended to read as follows:

SECTION 2. The owner or operator or duly designated agent of the owner or operator shall regain immediate possession of any motor vehicle removed, as aforesaid, from said towing service company or the person to whom or the place to which it may have been delivered by said towing service upon payment of a total charge of TEN (\$10) DOLLARS for towing, (if such towing was performed during the hours of 8 A.M. to 6 P.M. or FIFTEEN (\$15) DOLLARS for towing if such towing was performed during the hours of 6 P.M. to 8 A.M.) plus a storage charge after the first four (4) hours of ONE (\$1) DOLLAR per day (24 hours) or for a fraction thereof for storage off the public highway.

SECTION 2. This Ordinance shall take effect upon its passage, and all Ordinances inconsistent herewith are hereby repealed.

No. <sup>637</sup> **AN ORDINANCE** AMENDING CHAPTER 1874, "ESTABLISHING THE SALARIES AND COMPENSATION TO BE PAID TO THE SEVERAL CITY OFFICIALS AND EMPLOYEES HEREIN NAMED", AS APPROVED SEPTEMBER 25, 1967, BY ESTABLISHING AN AGENCY IN THE MAYOR'S OFFICE TO BE KNOWN AS MAYOR'S CITY DEMONSTRATION AGENCY AND ESTABLISHING THE SALARIES OF THE SEVERAL EMPLOYEES THEREOF. Chapter 1870 of the Ordinances of the City of Providence, as approved September 25, 1967, and entitled: "An Ordinance Making Appropriation of \$50,670,558.30 for the Support of the City Government for the Fiscal Year Ending September 30, 1968", is hereby amended by transferring the sum of Fifteen Thousand (\$15,000) from Water Fund-Payment to Sinking Fund to WATER FUND-ACCOUNTING and COMMERCIAL DIVISION, ITEM 3.

SECTION 2. The City Controller and the City Treasurer are hereby authorized and directed to pay over from the Water Fund-Accounting and Commercial Division, Item 3 to an account in the Trust and Special Funds to be entitled, "WATER METER CONVERSION REVOLVING FUND", the transfer herein made.

# RESOLUTION OF THE CITY COUNCIL

No. 670

Approved December 26, 1967

WHEREAS, there are presently located in the City of Providence certain structures which are in a dilapidated and deteriorated condition; and

WHEREAS, the City of Providence is vitally interested in the preservation and rehabilitation of neighborhoods throughout the City; and

WHEREAS, the demolition of certain of these structures will serve to promote the preservation and rehabilitation of these neighborhoods; and

WHEREAS, the owners of certain of these dilapidated and deteriorated structures are willing to convey title to these structures and to the land upon which they are located to the City of Providence without cost to the City; and

WHEREAS, by the acceptance of these deeds, the City of Providence will be enabled to demolish these structures with funds previously appropriated,

NOW, THEREFORE, BE IT RESOLVED, that the City of Providence hereby accepts deeds in fee simple to the land and buildings hereinafter described from the owners thereof:

1. That certain lot or parcel of land with all the buildings and improvements thereon situated in the City of Providence, State of Rhode Island, laid out and delineated as Lot 18 on that certain plat entitled "Plat of the Holbrook Land on Earles Street Belonging to Saml. Hedley Surveyed & Platted by C. E. Paine Nov. 1869" which said plat is recorded in the office of the Recorder of Deeds of said City of Providence in Plat Book 7 at page 27 and (copy) on Plat Card 201, conveyed to the City of Providence by Frank Rushe and wife Bridget M. Rushe.
