

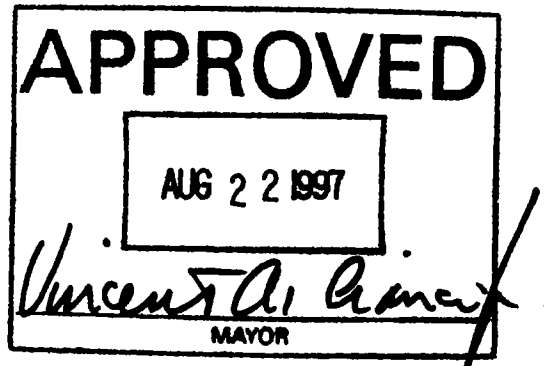

# Youth, 17, killed when his car hits phone pole

■ Police are still investigating but believe the Feinstein High School student may have fallen asleep while driving home.

PROVIDENCE — A 17-year-old Feinstein High School student was killed early yesterday when the car he was driving home veered off Allens Avenue and struck a telephone pole.

Police are still investigating the crash that killed Corey D. Figueiredo several blocks from his house at 299 Vermont Ave., but they believe he may have fallen asleep behind the wheel.

His father, Mario J. Figueiredo, complained that police never notified him of Corey's death. Edwin Barinas, 19, a childhood friend of Corey and neighbor at 297 Vermont Ave., told the father about the accident after stopping and seeing its aftermath when driving home.

The father went to the accident scene. Capt. John Ryan, the police spokesman, said police followed procedure in telling the father there to go to Rhode Island Hospital.

Ryan said the hospital will notify parents when their children die there. Corey was pronounced dead at Rhode Island Hospital at 12:30 a.m., about 9 minutes after his car struck the pole at 500 Allens Ave. head-on and caught fire.

The accident followed a day that friends and family said was typically goodhearted for Corey, a dark-haired soccer player who refereed youth athletics, sang in the church choir and served in his Washington Park neighborhood's crime watch program.

Corey was scheduled to graduate from the Alan Shawn Feinstein High School for Public Service next

month and was planning to study architecture in college next fall.

"He had told me," his father said, "Any time you want a new house, let me know. I'll design it for you."

Corey worked nights frying shrimp and grilling burgers at Ocean Express Seafood Restaurant. He had gotten a job at the Providence restaurant for his 16-year-old brother, Mario S. Figuereido.

The brother said he had gotten little sleep since hearing of the accident shortly after it occurred. "I can't sleep because if I close my eyes, I'll get a picture of [him]," the brother said.

Mourners said Corey was generous. When his aunt Julie Perez

bought a computer last year, he set it up. He also trimmed her hedges. Yesterday he helped his girlfriend's godmother prepare her hair salon for renovations by taping baseboards and unscrewing counters.

Figuereido and his girlfriend, Vanessa Medeiros, 15, then attended a religious feast at Our Lady of the Rosary Church in Providence. That was the last time Figuereido's family saw him alive, because at about 9:30 p.m. he and Medeiros left there to go to another feast in East Providence.

The two left the Phillips Street Hall at about 11:15 p.m., Medeiros said. They had coffee and doughnuts at a Dunkin' Donuts. Then, Figuereido dropped Medeiros off at her Seekonk house, grumbling, she said, about her father's strictness.

And then, he headed toward home.

## State parks, beaches to open by weekend

All state parks and beaches are scheduled to open by the Memorial Day weekend and the state is planning to charge the same fees as last year.

The beach pavilion and parking lot at Roger Wheeler State Beach (Sand Hill Cove) have undergone major reconstruction during the off-season, and DEM plans a reopening ceremony in June.

If you have old photographs of your family using Roger Wheeler Beach, DEM would like to use them for a special display. If you would like to loan your photograph, mail it to DEM's Division of Parks and Recreation, 2321 Hartford Ave., Johnston, R.I. 02919 along with a stamped, self-addressed envelope and information about when the picture was taken and who is in it.

Parking fees at state beaches remain at \$4 per car weekdays and \$5 weekends for Rhode Island residents; \$8 and \$10 respectively for non-residents. A season pass allowing admission to all state beaches is \$15 for residents and \$20 for non-residents.

season pass just for parks is \$10 for residents.

A new guide to parking spaces, restrooms, picnic tables and other amenities for the disabled at state parks and beaches is available by calling DEM at 277-2632. All of the state's major saltwater beaches have special chairs with wide rubber wheels to help the disabled get to the beach.

Here are the early-season schedules:

Scarborough North, Scarborough South, Salty Brine, East Matunuck, Charlestown Breachway and East Beach will be open daily, weather permitting, starting May 24.

Misquamicut State Beach in Westerly will open Memorial Day weekend and be open weekends only until June 21, when it will move into daily operations.

Limited services will be provided at Roger Wheeler State Beach.

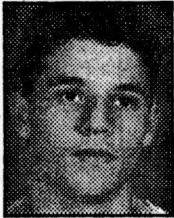

PROVIDENCE — Corey Dean Figueiredo, 17, of Vermont Avenue, a senior at the Alan Shawn Feinstein High School who was to have graduated next month, died Saturday at Rhode Island Hospital from injuries suffered in an auto accident early Saturday.



A lifelong Providence resident, he was a son of Mario Jorge and Mary Fatima (Silva) Figueiredo. He worked as a cook for the Ocean Express Restaurant on Allens Avenue for the last year.

He played for Capitol Youth Soccer of Providence. He was a soccer referee for the Task Force of the Mayor's Council on "Keep Children Off Drugs" in Washington Park. He was a baseball player for the Wash-

ington Park Little League for many years, and played on its all-star team in 1992.

He was a communicant of Holy Rosary Church.

Besides his parents, he leaves a brother, Mario Scott Figueiredo, at home; and his paternal grandparents, Antonio and Lourdes (Freitas) Figueiredo in Portugal. He was the maternal grandson of the late Manuel and Maria daSilva, and Adalia (Mota) Figueiredo.

## Feinstein grads recall classmate killed in crash

PROVIDENCE — Seniors at the Feinstein High School for Public Service traveled to Mexico for two weeks, others played basketball after school at Washington Park and still more chatted with Spanish exchange students.

They had their prom at the casino in Roger Williams Park, rollerbladed in the streets near Cranston and laughed at those who tripped on the carpet in their English classroom.

But those who graduated yesterday said they would most remember Corey D. Figueiredo, their classmate who was killed last month when his car veered off Allens Avenue and struck a utility pole.

"That last Friday we spent with Corey," was the memory Rafael Olivo Jr., 18, would always recall from the school year.

The Saturday that Corey was killed, students came to the school and talked about Corey and about death, said Katia Paris, Feinstein's

service learning coordinator. Paris said the gathering was a reflection of the students' love for Corey as well as their general good-heartedness.

Indeed, the high school is founded on a giving spirit. As part of their studies, students must perform community service, whether tutoring at other schools, volunteering at hospitals or helping out at nursing homes.

Last night's commencement was the school's second. It took place in Gaige Hall auditorium at Rhode Island College. Speaker after speaker

mentioned Figueiredo in their remarks, and Figueiredo was awarded a high school diploma posthumously.

we're here tonight."

Of all the classmates, the one whom graduates said they will most remember is Keary Chea, a senior honors student who died last December from a rare form of the flu.

His death, just before Christmas, "brought everyone down," said class vice-president Jessica Marrero. "But it also caused the class to pull together so that we became as one."

Last night's ceremony was also a reflection of the school's diverse ethnic mix, a diversity students said had been an important part of their education.

When she arrived in the United States four years ago, Alida Berganza, spoke no English. Last night she stood on the stage as class salutatorian. "Four years ago I did not believe I would ever learn English, let alone that I would be speaking to all of you as I am tonight."

The valedictorian, Victoria Bo-

given each other the strength to succeed," she said. "Now we must not forget the future is ours. . . . We must do everything in our power to create a better world."

In a special tribute to the school's late drama coach, it was announced that the school auditorium is being renamed the John A. Thomas Auditorium. In addition to presenting a plaque to Thomas's parents, Henderson announced that the class is giving \$1,000 to replace the worn-out chairs in the school's computer lab.

Mayor Vincent A. Cianci Jr. told the graduates they should "stand tall" for what they have accomplished, and went on to ask them to consider what they would do if he were to offer each of them \$86,400 to spend for the day, with an additional \$86,400 the day after.

In fact, he said, each of the graduates do have that amount to spend — not in dollars, but in the number of seconds in a day.

"So use those seconds," he said.
