No. 197 **AN ORDINANCE IN AMENDMENT OF CHAPTER 23, "STREETS, SIDEWALKS AND PUBLIC PLACES", ARTICLE I, ENTITLED: "IN GENERAL", OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, BY AMENDING SECTION 23-31, "USE OF SKATE BOARDS ON STREET, HIGHWAY, SIDEWALK, PEDESTRIAN MALL"**

Approved June 26, 2020

Be it ordained by the City of Providence:

Section 1: Sec. 23-31. - Use of skate boards on street, highway, sidewalk, pedestrian mall.

- (a) The use of skate boards shall be permitted in all areas, and in such manner, as permitted for the operation of a bicycle unless further restricted under this Section 23-31.
- (b) No person shall ride a skateboard within:
 - i. Waterplace Park;
 - ii. Memorial Park;
 - iii. The Providence River Pedestrian Bridge; and
 - iv. Such other locations as the City Council may from time to time designate through the installation of street signs that clearly identify the area within which skateboarding is prohibited.

Section 2: This ordinance shall take effect upon passage.



My name is Robert Spousta and I live at 274 Morris Avenue in Providence. I am writing to you as a property-owning constituent and concerned citizen to vigorously support the proposed amendment to Ordinance 27140. I am unequivocally in favor of lifting the ban on skateboards in our city.

I have been a skateboarder for over thirty years and am a living example of the valuable lessons that the sport teaches; namely perseverance, discipline, and an appreciation for rigorous physical exercise. As an adolescent, I was punished by school administrators for riding my skateboard to school and issued numerous citations for skateboarding in public spaces due to the fact that no designated skateboard spaces existed at that time. These experiences did not help me to trust or appreciate the role of authority figures. We can do better than this. Young skateboarders in Providence today deserve to know that the city encourages them to pursue their chosen sport. Skateboarding is a healthy activity for people of all ages and is also an environmentally friendly means of transportation. As Providence moves to become increasingly hospitable to alternative forms of transport such as cycling and motorized scooters, it is absolutely illogical and counterproductive to maintain legislation that arbitrarily criminalizes skateboarding. The current ban on skateboarding is especially alarming in light of the legal grey area that it creates in the event of a car striking a skateboarder. As a parent of young children, I find this extremely problematic. I look forward to teaching my son and daughter how to skateboard, but I do not want to explain to them that our sport is technically illegal.

I sincerely hope that the City Council is able to enact the proposed amendment to end the ban on skateboarding in Providence. It will certainly help to improve public safety while ameliorating a particularly antiquated piece of legislation.
