Resolved,

That the City Treasurer, acting under the direction of the Committee on Finance, be and he hereby is authorized and directed to borrow from time to time, in such sums as may be necessary, not exceeding one hundred fifty-two thousand (\$152,000) dollars, in addition to the sum of six hundred fifteen thousand (\$615,000) dollars heretofore authorized by Resolution No. 423, approved August 24, 1954, in accordance with the provisions of Sections 49 and 88 of Chapter 2574 of the Public Laws, 1950, entitled "Slum Clearance and Redevelopment Act"; and to issue the City's notes therefor, bearing interest at a rate not to exceed three and one-half percentum ($3\frac{1}{2}\%$) per annum, signed by him and countersigned by the Mayor and Chairman of the Committee on Finance, and to renew any such notes from time to time as the same become due. The money thus obtained shall be used exclusively for carrying out the purposes of a loan and grant contract between the Providence Redevelopment Agency and the House and Home Finance Agency of the United States of America for financing the Redevelopment Plan for the Willard Center, Unit One Area.

AND BE IT FURTHER RESOLVED, that the City Treasurer of the City of Providence is hereby authorized upon approval by the Finance Committee of the City of Providence to pay over to the Providence Redevelopment Agency, "Projects, Expenditures Account" Project No. U. R. R. I. 1-2, as an interim cash local grant in aid of the Project, so much of said sum as may be required by said Providence Redevelopment Agency from time to time, for the purposes aforesaid.

D. 1954, and approved February 11, 1954, entitled "An Act Authorizing the City of Providence to Issue Bonds in the Sum of Five Hundred Thousand (\$500,000) Dollars for School Purposes" for the purpose of modernizing school buildings, and to issue the City's notes therefor, bearing interest at a rate not exceeding three and one-half percentum ($3\frac{1}{2}\%$) per annum, signed by him and countersigned by the Mayor and Chairman of the Committee on Finance; and to renew any such notes from time to time as the same become due. The money thus obtained is hereby appropriated for, and shall be exclusively used and expended for the purposes named in this resolution.
