I desire to amend the Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain classes of the Department of Public Parks, Division of Grounds Maintenance Services and Repealing Ordinance Chapter 1982-40 as follows:
