

An Ordinance Amending Ordinance No. 296 Of Chapter 2017-22, Adopted June 20, 2017 Providing for the Assessment and Collection of 2017 Taxes in a Sum not less than Three Hundred Sixty Four Million Two Hundred and Sixty Four Thousand Five Hundred Twenty Eight Dollars (\$364,264,528) and not more than Three Hundred Eighty Million Five Hundred and Sixty Five Thousand and Five Hundred Sixteen Dollars (\$380,565,516) being based on a One Hundred Percent (100%) of the 2017-2018 Fiscal Year Tax Collections, and setting the rates for Fiscal Year 2019.


