Enclosed is a copy of a memorandum to Colonel Ricci regarding your request for enforcement of city parking regulations.

I heartily agree with the concern of the City Council for strict enforcement of parking rules and regulations. I also feel that the money penalty for violations should be raised. The cost of processing each violation properly exceeds the amount of the penalty. In addition, it is often cheaper to get the violation rather than pay a parking lot. It is my opinion that higher penalties and towing of violators can help reduce violations and, thereby, help traffic problems caused by illegal parking.




