# RESOLUTION OF THE CITY COUNCIL

No. 625

Approved December 24, 1973

WHEREAS, it has been reported that the Allegheny Airlines and American Airlines are proposing to reduce certain flights during prime time between the Theodore Francis Greene Airport, which services the City of Providence patrons, New York City, and Washington, D.C., and return flights to the same, and

WHEREAS, such proposed reduction in flights would cause inconvenience to patrons of these airlines, if reduced below a viable level,

NOW, THEREFORE, BE IT RESOLVED, that the Members of Congress from the State of Rhode Island are hereby urgently requested to use their good offices to avert a reduction of flights, during prime time, by the Allegheny Airlines and the American Airlines from the Theodore Francis Greene Airport to New York City and Washington, D.C., and flights from those points back to the said airport serving the City of Providence clientele and the Metropolitan Providence area.


It's good to know that you are back at work again and I certainly hope that you enjoy good health throughout the coming New Year.

You will kindly note, Senator, that in addition to American Airlines, it also involves Allegheny Airlines; and from information given me, it is not a rescheduling of flights but curtailment of certain prime time airflights.

In addition to the above concern, I was informed this morning, by telephone, that there will be a series of layoffs of personnel, one of which happened this morning to a 15-year veteran of American Airlines.

I am, this day, forwarding to both American and Allegheny copies of the instant Resolution and accompanying letter informing of the City of Providence's position on the proposed reduction of flights and its effect upon patrons utilizing those two airlines from the City of Providence, particularly.




Dear Vinnie:

Dear Mr. Chairman:

Both American Airlines and Allegheny Airlines have announced reductions in service between Providence and New York. This is a matter of utmost concern to me because of the adverse impact which this cutback will have on businesses in Rhode Island.

I am naturally aware that the energy crisis is resulting in a slightly reduced fuel allocation to the airlines, and we, in Rhode Island, want to cooperate, of course, with the Federal energy program. However, we do not appreciate being taken advantage of with the energy shortage as a convenient excuse. It appears that the airlines in this instance are trying to cut out routes they have been servicing and using the occasion of the fuel shortage as an opportunity to do that.

Needless to say, if the proposed flight reductions are allowed to stand, they will have a serious impact on the business community in Rhode Island. Thus, I would ask you to review this matter immediately and to act to prevent reductions in service.

Dear Representative St Germain:

Mr. Warde asked me to respond to your recent letter regarding our Providence schedules, as I have responsibility for scheduling at American Airlines.

Our decision to reduce the number of flights between Providence and New York was taken with great regret. However, as I am sure you are aware, the current fuel crisis has necessitated that the airlines reduce their total operations by a significant amount. In our own particular case, effective January 7 we have had to cut out approximately 25% of our planned departures.

In effecting flight cancellations, we have tried to follow three basic guidelines in order to minimize inconvenience to the travelling public:

1. to cancel, where possible, services which have had low patronage,
2. to cancel in markets where there will remain an adequate supply of service (both ours and the competition's), and
3. to make our cancellations throughout the system so that no one city or geographical area bears an unreasonable burden.

We are not happy with the cancellations we have been forced to make. I can assure you that we will give every consideration to your views when and if the fuel situation permits us to consider reinstatement of cancelled services.

This will acknowledge your letter of December 28, 1973, addressed to Leslie O. Barnes, President of Allegheny, forwarding a letter written by the Honorable Joseph A. Doorley, Jr., Mayor of the City of Providence, concerning Allegheny's service between Providence and New York City.

As I know you are aware, Allegheny was required to effectuate a 25% cut back in fuel consumption on January 7th, pursuant to an order issued by the President on November 25th. This drastic action required a major reduction in Allegheny's services throughout the system, within a very short period of time. Every effort was made to curtail services consistent with the public interest. In the case of the Providence-New York market, the existence of regular train service was a factor dictating the decision to curtail services in that market. We did retain critical air service in important Providence markets such as Washington, Philadelphia, Pittsburgh, Buffalo, Syracuse, Rochester and Minneapolis-St. Paul.

With the announced restoration of fuel to the 1972 level by the Federal Energy Office effective January 15, 1974, Allegheny is re-examining its system schedules with a view toward increasing services at many cities on March 1. Since the level of fuel available to Allegheny on that date will still be 7% below October 1973 requirements, Allegheny will not be in a position to restore all of the services which were operated last October. However, we anticipate that a reasonable pattern of service will be available to one of the New York City airports on March 1. As soon as the schedule is finalized, I will be pleased to forward it to you.


Dear Vinnie:


In the midst of this energy crisis with frequently dark days, we felt you might like to have this more encouraging news, namely, that Allegheny plans as of March 1st, to restore the following service to and from Providence:

1. 5 Non-stop roundtrips daily to Washington, D. C.
2. 3 Roundtrips daily to Newark at 7:30 a.m., 11:24 a.m. and 5:00 p.m. The early morning and late afternoon flights will continue to Rochester and Toronto, providing the first single-plane service between Providence and the Canadian hub.
3. New morning service to Detroit, departing at 8:19 a.m.
4. Restoration of non-stop service to Baltimore, with a departure at 11:02 a.m.
5. Increase from 3 to 5 daily flights to Philadelphia with continuing service to Nashville and Memphis.

The net effect of this schedule is an increase in daily flight frequency from 14 to 20 at present. Under new regulations established by the Federal Energy Office, Allegheny will receive approximately 7% less fuel than it used during October 1973.



There are currently five well-timed jet departures nonstop from Providence to Washington, and six well-timed jet departures from Washington to Providence. Accordingly, there does not appear to be any deficiency in Allegheny's service in this market.

I am writing in further reference to your letter of December 24, 1973 and my reply of January 14, 1974 concerning the present cut-back in airline service to Rhode Island.

As you are aware, severe reductions in fuel allocations forced our major airlines to severely curtail their schedules. In light of future findings, however, the Energy Office has now authorized airlines to receive 100 percent of their 1972 fuel usage. Happily, this increase in availability will enable Allegheny to resume a number of flights previously cancelled and to re-employ some of the 3,700 personnel who were forced out on "furlough". The proposed changes are not as yet finalized, but are scheduled to go into effect on March 1.

Dear Congressman Tiernan:

This will acknowledge your recent inquiry concerning Allegheny's service between Providence and New York City.

As you know, Allegheny was required to effectuate a 25% cut back in fuel consumption on January 7th, pursuant to an order issued by the President on November 25th. This drastic action required a major reduction in Allegheny's services throughout the system, within a very short period of time. Every effort was made to curtail services consistent with the public interest. In the case of the Providence-New York market, the existence of regular train service was a factor dictating the decision to curtail services in that market. We did retain critical air service in Providence markets such as Washington, Philadelphia, Pittsburgh, Buffalo, Syracuse, Rochester and Minneapolis-St. Paul.

With the announced restoration of fuel to the 1972 level by the Federal Energy Office effective January 15, 1974, Allegheny is re-examining its system schedules with a view toward increasing services at many cities on March 1. Since the level of fuel available to Allegheny on that date will still be 7% below October 1973 requirements, Allegheny will not be in a position to restore all of the services which were operated last October. However, we anticipate that a reasonable pattern of service will be available to one of the New York City airports on March 1. As soon as the schedule is finalized, we will let you know immediately.
