In accordance with the Provisions of Section 406 of the Providence Home Rule Charter of 1980, I am, this day, calling a Special Meeting of the City Council to be held on Monday, the 25<sup>th</sup> day of July 2005 at 7:00 o'clock P.M., in the City Council Chamber, Third Floor, City Hall for the purpose of acting upon the following:



*Now, Therefore, Be It Ordained By The City Of Providence:*

**Section 1.** To defray the expenses of the City of Providence for the fiscal year ending June 30, 2006, the sums of money or so much thereof, as are authorized by law, indicated in the accompanying schedule, are hereby appropriated for the objects and purposes, and in amounts expressed therein provided

that payments there under shall be subject to the provisions of the Home Rule Charter of 1980, validated by the General Assembly of the State of Rhode Island at its January Session, A.D., 1981, and approved November 4, 1980, and subject to the provisions of the City Ordinances relative to the expenditures of money from the City Treasury. Fiscal Assistance to State and Local Governments rules and regulations shall govern the portion of this Budget so designated.

**Section 2.** The payments to the School Fund of the following estimated receipts included in the appropriation of \$300,285,697 for the support of Public Schools for the City of Providence fiscal period 2005-2006, will be increased or decreased to conform with the actual amounts received from such sources during the City of Providence fiscal year 2005-2006.

**Section 3.** Any transfer to the General Fund from Expendable Trust Funds shall be restricted to and deemed to be utilized for the reduction of debt obligations of the City of Providence, as provided for in Section 808 of the Home Rule Charter.

**Section 4.** The provisions included in this ordinance supersede any prior ordinances or any provisions thereof.

**Section 5.** Notwithstanding the provisions of Section 17-185 and Section 17-186 of the Code of Ordinances, the amount of \$39,992,080 is hereby appropriated to the Pension Accumulation Fund, reflecting a 30-year amortization of the pension liability.

**Section 6.** No payments can be made from the general fund to employees that were originally hired under non-local source funds without prior approval from the City Council through an Ordinance.

**Section 7.** There shall be an allocation in the amount of \$50,000 to the Miscellaneous Services line item in the Department of Planning & Development. Said allocation shall be used to supplement an already existing allocation of \$100,000 in the City Revolving Fund Account for the purpose of First Source ordinance implementation.

**Section 8.** This ordinance shall take effect upon passage.

SECTION 1. The aforescribed Compensation Plan is hereby adopted for all City Officers and employees and shall be applied to each, except as hereinafter provided.

SECTION 2. The salary for each position is categorized as one (1) of sixty-five (65) "Pay Grades", each of which contains five (5) "Steps". The "Pay Grades" and "Steps" are enumerated and set forth in Table I (Grade 1 -

Grade 35) and Table II (Grade A1-Grade A30).

SECTION 3. Notwithstanding any other provision of this Ordinance, any and all employees in the Office of the Mayor shall be excepted from any salary established herein so long as the total of the compensation for such employees does not exceed the annual budget appropriation for personnel services in the Office of the Mayor.

SECTION 4. Notwithstanding any other provisions of this Ordinance, the compensation for positions approved by the Salary Review Commission and legal assistants to the City Solicitor shall be no greater than those herein specified; however, any department head or legal assistant to the City Solicitor may be compensated at a rate lower than that established herein, and that lower compensation shall be allowed by this Ordinance.

SECTION 5. Effective with the adoption of this Ordinance, Officers and Employees of the City of Providence may authorize Employees to perform duties of a higher rated classification only when a temporary vacancy exists in the higher rated

classification, caused by leave or retirement, and that said position is funded and provided for in this Ordinance. Said assignment may be for a maximum of 90 days per fiscal year with notice to the Personnel Director. Any period longer than 90 days shall be approved by the Personnel Director and such approval with reasons for the extension shall be provided to the City Council.

SECTION 6. The provisions of this ordinance shall not be construed as a ratification of any collective bargaining agreement.

SECTION 7. This Ordinance shall take effect upon passage.

**The Following Ordinances were in City  
Council July 21, 2005, Read and Passed  
The First Time and are Severally  
Returned for Passage the Second Time:**

An Ordinance Providing for the Assessment and Collection of 2005 taxes in a sum not less than Two Hundred Forty Five Million Dollars (\$245,000,000), and not more than Two Hundred Sixty Five Million (\$265,000,000), being based on a One Hundred Percent (100%) of the 2005-2006 Fiscal Year Tax Collections, Amending Section 21-182 of the Code of Ordinances to reflect the new Tax Classification Plan approved by the Rhode Island General Assembly, Amending Section 21-126 of the Code of Ordinances to raise the Personal Exemptions, and setting the Homestead Rates for Fiscal Year 2006.

*Be it ordained by the City of Providence:*

Section 1. The City Council of the City of Providence, hereby orders the assessment

and collection of a tax on the ratable real estate and tangible personal property, as well as orders the assessment and collection of an excise tax on all registered motor vehicles, in a sum not less than TWO HUNDRED FORTY FIVE MILLION DOLLARS (\$245,000,000) AND NOT MORE THAN TWO HUNDRED SIXTY-FIVE MILLION (\$265,000,000) being one hundred percent (100%) of the 2005-2006 year tax collection, as amended; said tax is for ordinary expense charges and for the payment of interest and indebtedness in whole or in part of said City and for other purposes authorized by law.

Section 2. The City Assessor shall assess and apportion said tax on inhabitants and ratable real estate and tangible personal property of said City as of the 31<sup>st</sup> day of December AD 2004 midnight, Eastern

Standard Time, as well as assess and apportion said excise tax on owners of registered motor vehicles in the City of Providence during calendar year 2004, according to law, and shall on completion of said assessment, date and sign, and shall make out and certify to the City Collector of the City of Providence, on or before the 15<sup>th</sup> day of June, AD 2005 a complete listing containing (1) the names of persons taxed and the total value of all real estate taxed to each; (2) amount of the personal estate except manufacturer's machinery and equipment assessed against each person; and (3) the amount of said motor vehicle excise assessment against each person, on said real estate, personal estate and motor vehicle opposite the name of the person or persons assessed.

The assessment of real estate, personal estate and motor vehicles shall appear on separate lists.

Said taxes shall be due and payable on and between the first day of July, AD 2005, next, and the twenty fourth day of July, AD 2005, next, and all taxes remaining paid said last named day shall carry until collected a penalty at the rate of twelve per centum (12%) per annum upon such unpaid real estate, personal estate and excise taxes.

Said taxes may be paid in four installments, the first installment of twenty-five per centum (25%) on or before the twenty-fifth day of July, AD 2005, next, and the remaining installments as follows:

Twenty-five per centum (25%) on the  
Twenty-fourth day of October, AD 2005  
Twenty-five per centum (25%) on the  
Twenty-fourth day of January, AD 2006

Twenty-five per centum (25%) on the  
Twenty-fifth day of April, AD 2006

Each installment period successively and in order shall be free from any charges for interest. Provided, however, the option to pay taxes in quarterly installments shall not apply to any tax levied in an amount not in excess of \$100.00. If the first installment or any succeeding installment of taxes is not paid by the last day of the respective installment period or periods as they occur, then the whole tax or remaining unpaid balance of the tax, as the case may be, shall immediately become due and payable and shall carry until collected a penalty at the rate of twelve per centum (12%) per annum on said real estate, personal estate and excise taxes.

The City Collector shall by advertisement in a public newspaper of the City notify all persons assessed to pay their respective taxes at his/her office; said Collector shall attend daily, Saturdays, Sundays, and holidays excepted at his/her office from eight-thirty o'clock a.m. to four o'clock p.m. to receive taxes.

Section 3. This ordinance is enacted pursuant to Rhode Island General Laws 44-5-2 (a).

Section 4. Section 21-182 of the Code of Ordinances, entitled "Apportionment of taxes," is amended as follows:

(a) The tax classification plan is hereby adopted with the following limitations:

(1) The designated classes of property shall be limited to the four (4) classes as defined in subsection (b).

(2) The tax rate for Class 2 shall not be more than two times the tax rate of Class 1, without regard to any applicable homestead exemption; the tax rate applicable to Class 3 shall not exceed the tax rate of Class 1 by more than two hundred percent (200%).

(3) Notwithstanding subdivisions (a)(2), the tax rate applicable to wholesale and retail inventory within Class 3 as defined in subsection (b) are governed by General Laws, section 44-3-19.1.

(4) Notwithstanding subdivisions (a)(2), tax rates applicable to motor vehicles within Class 4 as defined in subsection (b) are governed by General Laws, section 44-34.1-1.

(5) The provisions of General Laws, chapter 35 of title 44 relating to property tax and fiscal disclosure applies to the reporting of and compliance with these classifications.

(b) *Classes of property.*

(1) *Class 1.* Residential real estate consisting of no more than five (5) dwelling units, land classified as open space, and dwellings on leased land including mobile homes. This class may also include residential properties containing partial commercial or business uses and residential real estate of more than five (5) dwelling units. A homestead exemption is authorized within this class as follows: (a) owner-occupied residential real estate may be granted an exemption in an amount not to exceed fifty (50) per cent of the assessed valuation; except that owner-occupied residential real estate consisting of more than five (5) units may be granted an exemption in an amount not to exceed fifty

(50) per cent of the assessed valuation attributable to the first five (5) units. Owner-occupied mixed use real estate may be granted an exemption in an amount not to exceed fifty (50) per cent of the assessed valuation attributable to the first five (5) units. Non-owner-occupied mixed used real estate may be granted an exemption in an amount not to exceed fifty (50) per cent of the assessed valuation attributable to the first five (5) units of the residential portion of such real estate. The percentage reduction in valuation of residential real estate pursuant to the homestead exemption shall apply to residential real estate containing five (5) or fewer dwelling units. In the case of multiple dwellings containing more than five (5) dwelling units, the percentage reduction in valuation shall be applied to the result of dividing the assessed valuation by the number of dwelling units in the multiple dwelling and multiplying the quotient by five (5).

The granting of an application for an owner-occupied or non-owner-occupied homestead exemption as referenced above as (a) or (b) is subject to the following limitations:

a. To be eligible for an (a) or (b) type homestead exemption, effective as to the assessment date of December 31 at midnight an applicant must file with the city assessor no later than July 31 a homestead exemption application, together with a declaration and present evidence, under oath or affirm, as to the owner-occupied or non-owner-occupied status together with any other proof of residency or ownership which may be required by the city assessor, except that for the assessment year ending December 31, 2000 the city assessor may utilize the

data collected during the revaluation of real property for the assessment date of December 31, 2000 to establish the applicable type of homestead exemption.

b. Only natural person(s) are qualified to receive the type (a) owner-occupied residential real estate homestead exemption. Real property which is partially or wholly owned by a business; an institution, a non-profit organization, a financial institution that has foreclosed on real estate, including HUD and Rhode Island Housing and Mortgage Finance Corporation or any other such public or private entity do not qualify for a type (a) owner-occupied homestead exemption.

c. Only a natural person(s) may qualify for one (1) type (a) owner-occupied homestead exemption in the city at any one (1) point in time.

d. The homestead exemption (a) or (b) attaches to the owner(s) of the real property not to the real property itself.

e. The city assessor shall deny an application for the homestead exemption filed under either type (a) or (b) if the city assessor determines that an execution of record based upon a judgment of the housing court for a real estate code violation(s) against the applicant remains unsatisfied.

f. In the event the property granted an exemption is sold or transferred during the year for which the homestead exemption is claimed, the exemption is void for that portion of the year following the sale or transfer. The buyer or transferee shall be liable to the city for

any tax benefit received after the date of sale or transfer.

g. If the taxpayer knowingly gives misinformation as to ownership and/or occupancy of the real estate on his/her application for a homestead exemption, the city assessor may, in such event, remove the homestead exemption and recalculate the tax for the period in question and in addition charge the taxpayer the maximum interest permitted by law.

h. The city assessor is empowered to promulgate any further rules and regulations which he/she deems necessary to carry out the intent and purpose of this ordinance as it relates to the homestead exemption.

(2) *Class 2.* Commercial and industrial real estate, residential properties containing partial commercial or business uses and residential real estate of more than five (5) dwelling units. Properties containing partial commercial or business uses and residential real estate of more than five (5) dwelling units may be included in class 1.

(3) *Class 3.* All ratable tangible personal property.

(4) *Class 4.* Motor vehicles and trailers subject to the excise tax created by General Laws, title 44, chapter 34.

(c) The city, pursuant to General Laws, section 44-5-11.8(c), adopts a tax rate for Class 2 which shall not be more than two times the tax rate of Class 1, without regard to any applicable homestead exemption; the tax rate applicable to Class 3 shall not exceed



the tax rate of Class 1 by more than two hundred percent (200%).

Section 5. In keeping with the authorization provided in Rhode Island General Laws Section 44-3-31, Section 21-126 of the Code of Ordinances is hereby amended as follows:

Notwithstanding any other provisions of general or special law to the contrary, the amount of the following exemptions with respect to the assessed value from local taxation on taxable property is fixed as follows:

(a) Veterans as defined in Section 44-3-4 of the General Laws of Rhode Island and the unmarried widow or widower of such veterans at four thousand five hundred dollars (\$4,500.00)

(b) Blind persons as defined in Section 44-3-12 of the General Laws of Rhode Island at twenty-seven thousand dollars (\$27,000.00).

(c) Veterans who are totally disabled as defined in Section 44-3-4 at nine thousand dollars (\$9,000.00).

(d) Gold Star Parents as defined in Section 44-3-5 of the General Laws of Rhode Island at thirteen thousand five hundred dollars (\$13,500.00).

(e) Specially adapted housing for paraplegic veterans as defined in Section 44-3-4 of the General Laws of Rhode Island at forty-five thousand dollars (\$45,000.00).

(f) For any person sixty-five (65) years of age or over at fifteen thousand dollars (\$15,000.00);

(g) For persons who are one hundred percent (100%) disabled as determined pursuant to title II and title XVI of the Social Security Act, 42 U.S.C. § 401 et seq., and 42 U.S.C. § 1381 et seq., as amended, or who, by reason of their being one hundred percent (100%) disabled, are receiving disability payments from sources other than the social security administration (such as employees of the railroad, federal civil service, postal service, and the Providence police and fire departments) at thirteen thousand five hundred dollars (\$13,500.00).

(h) For any person sixty-two (62) through sixty-four (64) years of age, who is receiving social security benefits, thirteen thousand five hundred dollars (\$13,500.00).

Provided, however, that any such increase in exemption provided for herein over the amount heretofore provided by general or special law shall apply only to real property.

Section 6. Effective for Fiscal Year 2005, and until changed, the homestead exemption shall be set as follows:

Residential real estate consisting of no more than five (5) dwelling units, land classified as open space, and dwellings on leased land including mobile homes. A homestead exemption is authorized within this class as follows: (a) owner-occupied residential real estate may be granted an exemption in an amount not to exceed fifty (50) per cent of the assessed valuation; except that owner-occupied residential real estate consisting of more than five (5) units may be granted an exemption in an amount not to exceed fifty (50) per cent of the assessed valuation attributable to the first five (5) units. Owner-occupied mixed use real estate may be granted an exemption in an amount

not to exceed fifty (50) per cent of the assessed valuation attributable to the first five (5) units of the residential portion of such real estate; or (b) in the case of non-owner-occupied residential real estate consisting of five (5) dwelling units or less an exemption in an amount not to exceed thirty-three (33) per cent of the assessed valuation may be granted. Non-owner-occupied residential real estate consisting of more than five (5) dwelling units may be granted an exemption in an amount not to exceed thirty-three (33) per cent of the assessed valuation attributable to the first five (5) units. Non-owner-occupied mixed use real estate may be granted an exemption in an amount not to exceed thirty-three (33) per cent of the assessed valuation attributable to the first five (5) units of the residential portion of such real estate. The percentage reduction in valuation of residential real estate pursuant to the homestead exemption shall apply to residential real estate containing five (5) or fewer dwelling units. In the case of multiple dwellings containing more than five (5) dwelling units, the percentage reduction in valuation shall be applied to the result of dividing the assessed valuation by the number of dwelling units in the multiple dwelling and multiplying the quotient by five (5).

Section 7. This ordinance shall take effect upon its passage.

#### **SECTION 60**

The number of employees in the Office of the Mayor shall not be limited. The Mayor may appoint without reference to civil service provisions and without the necessity for approval by the City Council a Chief of Staff and such Deputies, Assistant's, Aides, Secretaries, Stenographers, Clerks and other personnel, as he may deem necessary.

#### **SECTION 61**

No person shall be appointed to, and the City Treasurer shall not pay, nor shall an officer or employee of the city issue a check for the payment of, nor pay any salary or compensations to a person holding or claiming to hold a position in the classified service in any department which is in excess of the total number of positions or the number of any individual class of positions provided herein for the particular department; provided,

however, that with the approval of the department head and the Director of Finance, said maximum may be exceeded temporarily when regular employees are absent on vacation and the excess employees do not aggregate more than the number on vacation or during the absence of employees, due to injuries received while discharging their duties as employees or during absences of employees on sick leave, and it is necessary to employ temporary employees for the duration of the employee's sick leave, or during the absence of employees who have been granted a temporary leave of absence or when in the opinion of the Director of Finance, a temporary emergency exists.

#### **SECTION 62**

Where no maximum limit is fixed on the total number of positions or the number of any individual class of positions in a department, the number of persons appointed and employees shall be determined by the unexpended appropriation available.

#### **SECTION 63**

Effective with the adoption of this Ordinance, Officers and Employees of the City of Providence may authorize Employees to perform duties of a higher rated classification only when a temporary vacancy exists in the higher rated classification, cause by leave or retirement, and that said position is funded and provided for in this Ordinance. Said assignment may be for a maximum of 90 days per fiscal year with notice to the Personnel Director. Any period longer than 90 days shall be approved by the Personnel Director and such approval with reasons for the extension shall be provided to the City Council.

#### **SECTION 64**

This Ordinance shall take effect upon passage.

An Ordinance in Amendment of Ordinance Chapter 2005-3 No. 44, An Ordinance to Authorize the Issuance of Special Obligation Tax Increment Refunding Bonds of the City of Providence to refund the outstanding portion of its \$13,260,000 Special Obligation Tax Increment Bonds, Series A dated February 15, 1995, \$10,435,000 Special Obligation Tax Increment Bonds, Series B (Taxable) dated March 8, 1995 and \$2,805,000 Special Obligation Tax Increment Bonds, Series C (AMT) dated March 8, 1995 and \$11,000,000 Special Obligation Tax Increment Bonds, Series D dated April 1, 1996.

*Be it ordained by the City of Providence:*

Ordinance Chapter 2005-3, No. 44 adopted by the City Council on February 17, 2005 and approved by the Mayor on February 28, 2005 is amended and restated to read as follows:

**SECTION 1.** The City of Providence (the "City") has previously issued its \$13,260,000 Special Obligation Tax Increment Bonds, Series A dated February 15, 1995, \$10,435,000 Special Obligation Tax Increment Bonds, Series B (Taxable) dated March 8, 1995, \$2,805,000 Special Obligation Tax Increment Bonds, Series C (AMT) dated March 8, 1995, and \$11,000,000 Special Obligation Tax Increment Bonds, Series D dated April 1, 1996 (the "Prior Bonds").

**SECTION 2.** The City desires to issue special obligation tax increment refunding

bonds (the "Refunding Bonds") to refund the Prior Bonds in order to take advantage of the lower interest rates which currently are prevailing.

**SECTION 3.** The City is authorized pursuant to Section 10 of Chapter 33.2 of Title 45 of the General Laws of Rhode Island, as amended, to issue its Refunding Bonds to pay all or any designated part of an issue of bonds then outstanding, including principal, redemption premium, if any, interest on the outstanding bonds coming due on or prior to the date on which those bonds are to be redeemed, and the cost of issuing the Refunding Bonds.

**SECTION 4.** The City has determined that refunding some or all of the outstanding Prior Bonds in order to obtain debt service savings would result in financial benefits to the City.

**SECTION 5.** It is hereby declared that the Refunding Bonds authorized hereby will be within all debt and other limitations prescribed by the Constitution and laws of the State of Rhode Island.

**SECTION 6.** The City is hereby authorized to issue its Special Obligation Tax Increment Refunding Bonds in an amount necessary to refund some or all of the outstanding Prior Bonds and to provide for any principal, redemption premium, and interest on the outstanding Prior Bonds coming due on or prior to the date on which those Prior Bonds are to be redeemed, and the costs of issuance.

**SECTION 7.** The manner of sale, denominations, maturities, interest rates and other terms, conditions and details of the

Refunding Bonds shall be determined by the City Treasurer and the Mayor.

**SECTION 8.** The City Council hereby authorizes the City Treasurer, with approval of the Mayor, to issue the Refunding Bonds for the purposes set forth herein and to take all actions as he deems necessary to effect the issuance of the Refunding Bonds. The Refunding Bonds shall be issued by the City under its corporate name and seal or a facsimile of such seal. The Refunding Bonds shall be signed by the manual or facsimile signature of the City Treasurer and the Mayor.

**SECTION 9.** The City Treasurer and the Mayor are hereby authorized to issue the Refunding Bonds and deliver them to the purchaser and, if applicable, said officers are hereby authorized and instructed to take all actions, on behalf of the City, necessary to ensure that interest on the Refunding Bonds will be excludable from gross income for federal income tax purposes and to refrain from all actions which would cause interest on the Refunding Bonds to become subject to federal income taxes.

**SECTION 10.** The proceeds arising from the sale of such Refunding Bonds, exclusive of any premium, accrued interest and costs of issuance, shall, upon the receipt be paid immediately to the paying agent, paying agents, trustee or trustees for the Prior Bonds, and such paying agents shall hold the proceeds in trust until they are applied to pay or refund the Prior Bonds. While such proceeds are held in trust, they may be invested as permitted by applicable law.

**SECTION 11.** The City's Finance Director is authorized to execute and deliver a continuing disclosure certificate in

connection with the Refunding Bonds issued by the City, in such form as shall be deemed advisable by the City's Finance Director. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of the continuing disclosure certificate, as it may be amended from time to time. Notwithstanding any other provision of this Ordinance or the Refunding Bonds, failure of the City to comply with the continuing disclosure certificate shall not be considered an event of default; however, any bondholder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Ordinance and under the continuing disclosure certificate.

**SECTION 12.** In order to enhance the marketability of the Bonds, the City Treasurer and the Mayor are authorized to enter into an agreement which provides that in the event that the debt service reserve fund for the Bonds is below the debt service reserve fund requirement for the Bonds, that the Mayor shall submit a request to the City Council to fund the amount of any shortfall. Any such agreement shall provide that such payment shall be subject to appropriation by the City Council.

**SECTION 13.** This Ordinance shall take effect upon its approval by the Mayor after its passage.

---

An Ordinance Relating to Clean Renewable Energy Resources.

*Be it ordained by the City of Providence:*

**SECTION 1.** Renewable Energy Purchasing Goal: The City of Providence shall, starting

in the fiscal year 2010, purchase at least 20% of the energy it consumes clean, renewable sources. The City shall begin to make renewable energy the fiscal year 2006, increasing its renewable purchases over time so as to achieve the 20% goal.

**SECTION 2.** Satisfaction of 20% Goal: The City shall achieve the 20% requirement by using renewable energy as defined in Section 39-26-5 of Rhode Island General Laws. The City need not produce such energy itself, but may satisfy the 20% goal by purchasing Renewable Energy Credits.

**SECTION 3.** Establishment of Energy Task Force:

1. The City shall establish an Energy Task Force to study the scenarios by which the City could meet the 20% by 2010 goal, including the investigation of funding opportunities and the creation of clean energy installations.
2. The Energy Task Force shall consist of 7 individuals, three of whom shall be appointed by and serve at the pleasure of the City Council, three of whom shall be appointed by and serve at the pleasure of the Mayor, and one of whom shall be chosen by and represent the Environment Council of Rhode Island.
3. The Energy Task Force shall meet as often as necessary, but shall meet once within 90 days of the passage of this ordinance, and at least once each quarter until the implementation plan for the 20% by 2010 goal is completed.
4. Six months after passage of this ordinance and every six months



thereafter the Clean Energy Task Force will file a final report detailing its recommendations made towards the 20% by 2010 goal to the City Council for consideration. The Energy Task Force shall continue to meet and file reports as described above until it is discontinued by ordinance.

5. City departments, agencies and their staff shall cooperate with the Energy Task Force by providing them with relevant documents and information in a timely manner.
6. This Ordinance shall take effect upon passage.




