ORDINANCE CHAPTER 1981-39, EFFECTIVE JULY 20,  
1981, BY TRANSFERRING CERTAIN SUMS OF MONEY  
WITHIN THE DEPARTMENT OF PUBLIC SCHOOLS.

**Be it ordained by the City of Providence:**

SECTION 1. Chapter 1981-39, of the Ordinances of the City of Providence, effective July 20, 1981, entitled: An Ordinance Making an Appropriation of One Hundred Forty-Nine Million, Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars and Nine Cents (\$149,862,122.09) as amended, is hereby further amended by transferring certain sums of money within the Department of Public Schools as follows:

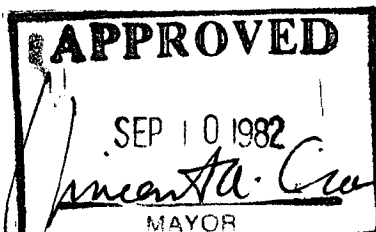


Enclosed is a copy of the School Committee resolution which was passed last night amending the school department budget.
