No. AN ORDINANCE IN AMENDMENT OF SECTIONS 1 AND 5
OF CHAPTER 763 OF THE 1953 ORDINANCES, ESTABLISHING A COMPENSATION
PLAN.

Approved

Be it ordained by the City of Providence:

SECTION 1: Those portions of Section 1 and sub-Section 7 of Section 5 of Chapter 763 of the Ordinances of 1953 entitled "An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Chapter 535, approved September 21, 1951" insofar as said portions refer to compensation for personnel of the Police and Fire Departments, are hereby amended to read as follows:

Sec. 7. The minimum rate for Fire Battalion Chief, Fire Chief, Fire Captain, Fire Lieutenant, Fireman, Police Captain, Police Chief, Police Commander, Police Lieutenant, Police Sergeant, Police Patrolman, Police Woman shall be the minimum established in Section 1 for such personnel, and shall automatically increase in accordance with the following schedule until the maximum is reached:

SEC. 2. This ordinance shall take effect ~~upon its passage~~ *on October 1, 1955 after passage by the City Council and approved by the Mayor and the Board of Aldermen* and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.
