- WHEREAS**, The climate crisis is one of the greatest challenges of our time; and  
**WHEREAS**, Continued increases in global temperatures will devastate both human communities and natural ecosystems; and  
**WHEREAS**, Rhode Island will be hit particularly hard as it has experienced the fastest temperature rise of any state in the continental United States; and  
**WHEREAS**, Rhode Island faces increased storm intensity, flooding, heat waves, asthma, insect-borne diseases, crop and fishery failures, accelerating coastal erosion, and sea level rise of up to 11.5 feet this century as a direct result of climate change; and  
**WHEREAS**, Climate change especially heightens the vulnerability of disadvantaged communities which bear environmental and socioeconomic burdens as well as legacies of discrimination; and  
**WHEREAS**, The State of Rhode Island and its local governments must take immediate action to dramatically reduce greenhouse gas emissions by phasing out fossil fuels, create a just and equitable transition to a stable economy, and invest in adaptation and resilience to protect the people and places we love; and  
**WHEREAS**, Actions undertaken by Rhode Island to cut greenhouse gas emissions must prioritize the safety, health, and economic well-being of disadvantaged communities; and  
**WHEREAS**, Transitioning our power generation away from fossil fuels to clean, locally generated, renewable energy creates good, family-sustaining jobs; and  
**WHEREAS**, Although dramatic emissions reductions are necessary to avoid the most severe impacts of climate change, complementary adaptation measures will also be needed to address those risks that cannot be avoided; and  
**WHEREAS**, The Environmental Council of Rhode Island's Climate Crisis Campaign is working to elevate climate issues and the need for policy solutions within at the state and local level.  
**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council does hereby endorse the Environmental Council of Rhode Island's Climate Crisis Campaign.

## COUNCILMAN CORREIA

Resolution Requesting the Director of Public Property make immediate repairs at the Providence Public Safety Complex.

**WHEREAS**, The Department of Public Property is responsible for maintenance of all publicly owned buildings in the City; and

**WHEREAS**, The Providence Public Safety Complex is over 15 years old and in need of immediate maintenance; and

**WHEREAS**, It has come to the Council's attention that the following items are in need of immediate repair: the entryways and ramps in the parking lot areas are in poor condition; the padding in certain cells need to be replaced; there are several leaks in the ceilings of the facility; additional security cameras are required for proper monitoring of the property; several entryways to the building are not adequately secure; the audio/visual equipment must be upgraded; along with numerous other general maintenance tasks throughout the building and municipal parking garage; and

**WHEREAS**, Without immediate repairs there is a potential that the facility will fall into a state of disrepair such that it will pose a risk to the health and safety of both public employees and Providence residents who use the complex.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council of the City of Providence does hereby request that the Director of Public Property make immediate repairs at the Providence Public Safety Complex.

**BE IT FURTHER RESOLVED**, That, the Council requests that within sixty days of passage of this resolution, the Mayor of Providence and the Director of Public Property provide the Council with an assessment of all repairs needed in the facility as well as a report outlining the steps being taken to complete said repairs.

**WHEREAS**, Affordable housing is an essential part of safe, resilient, healthy, and dynamic neighborhoods; and

**WHEREAS**, Chapter 13, Article III of the Providence Code of Ordinances establishes the Providence Affordable Housing Trust Fund; and

**WHEREAS**, The Providence Affordable Housing Trust Fund provides funding for the purpose of funding construction, development or financing mechanisms of affordable housing for families earning less than one hundred twenty (120) percent of the median income for the City; and

**WHEREAS**, Pursuant to Rhode Island General Law §44-25-1, et. seq., the City of Providence collects a real estate conveyance tax at a rate of \$2.30 for every \$500 of value on real property sold within the municipality where residential and commercial properties are located; and

**WHEREAS**, Rhode Island General Law §44-25-1, et. seq., allows the City of Providence to retain \$1.10 of every \$2.30 of real estate conveyance tax imposed; and

**WHEREAS**, According to the Internal Auditor, the City of Providence, during fiscal years 2010-2019, has retained \$16,016,135.76 through the collection of the state's real estate conveyance tax and has retained \$1,679,397.79 from July-December in fiscal year 2020; and

**WHEREAS**, The City of Providence has not allocated any revenue derived from the state's real estate conveyance tax toward affordable housing initiatives, projects or construction from 2010-2019, according to the Internal Auditor; and

**WHEREAS**, The City of Providence does not currently allocate any of its real estate conveyance tax revenue to the Affordable Housing Trust Fund.

***NOW, THEREFORE, BE IT RESOLVED***, That the Providence City Council does hereby request that the Mayor of Providence include in his Fiscal Year 2021 budget submission a provision allocating fifty percent (50%) of all retained real estate conveyance taxes to the Providence Affordable Housing Trust Fund.
