

Resolved,

That any structure above or under the ground hereafter constructed and located in the City of Providence on that tract or parcel of land bounding on Aborn Street containing approximately 10,097 square feet of land and designated as Lot 341 on Assessor's Plat 26 in use by the City Assessor of the City of Providence and used by the public for the parking of automobiles off the street or highway, shall be exempt from any assessment of valuations and levy of taxes thereon for a period of twelve (12) years beginning December 31, 1959, provided that

1. The construction of such structure results in at least a 200% increase in the parking capacity of the premises as they existed prior to erection of said structure.
2. The exemption shall be limited to that portion of the structure exclusively used for or devoted to the parking of automobiles and vehicles of that nature.
3. The exemption herein granted shall be for such structure whether owned by Rosedale Realty Co. or any other firm or corporation.

Dear Hector:

In our telephone conversation last week you requested a statement relative to the desirability of granting tax exemption for the proposed parking garage to be located on Aborn Street. In reviewing the minutes of the City Plan Commission meetings I find that this matter was discussed on March 8th and the following statement is in the approved minutes of that meeting:

"There was some discussion on a parking deck proposed to be located on Aborn Street. Since this is purely a matter of Council action on tax exemption of the proposed structure it will not be formally referred to the Commission for action. It was the consensus of the Commission that tax exemption for the proposed parking deck would be undesirable."

The Downtown Master Plan proposes a Convention and Sports Arena which would be located on the site of the proposed garage. This Sports Center, as you know, has received considerable interest from various quarters. The reason for the statement quoted in the Commission minutes was that it would be unfortunate to encourage the construction of a parking deck in this location and then subsequently have to condemn it and pay for the new structure in order to build the Sports Center. It would seem to us then desirable for this reason to withhold tax exemption privileges for this garage.

1. In view of the proposed Downtown Master Plan, will it be a policy of the City Plan Commission to deter any renovation and/or construction in the downtown area?
2. Is the proposed auditorium building, as suggested in the Downtown Master Plan, going to occupy the site concerned in the Rosedale Realty Company taxation exemption resolution, or will this portion of that area become the parking area to the proposed auditorium?
3. Assuming the Rosedale project is effected, could the parking structure be utilized in conjunction with the proposed auditorium or would it have to be demolished?

The Committee on Finance will consider this Resolution at its meeting to be held on Monday May 16, 1960 at 12:00 o'clock M, and therefore would appreciate immediate response to the above questions.

Memorandum To: Councilman Hector D. Laudati

Date: May 13, 1960

In reference to your memorandum of May 1st relative to tax exemption for off-street parking on Aborn Street, I am submitting the following answers to the three questions raised:

1. Obviously, it cannot be a policy of the City Plan Commission to deter renovation and/or construction in the Downtown Area or elsewhere. It does, however, seem to be appropriate for this Department to express its opinion when it observes that a possible serious conflict may be in the making. Policy of the type mentioned in the question must of necessity rest with the City Council and the Executive Department.

2. The proposed auditorium building, as suggested in the Downtown Master Plan, will in part occupy almost the entire site concerned in the instant case.

3. Although it might be perhaps possible to utilize the proposed parking structure in conjunction with the proposed auditorium it is highly improbable that the auditorium could be designed within the required limits for such a structure and adapt itself to a relatively small parking facility located without considerations to the development of the entire auditorium area.
