## A G R E E M E N T

WHEREAS, an act entitled, "An act in amendment of, and in addition to, Chapter 1443 of the Public Laws of 1929", passed at the January Session of the General Assembly of the State of Rhode Island, A. D. 1931, and numbered Chapter 1779, authorized and empowered cities and towns owning ratable property devoted to public use located within any other city or town to enter into an agreement fixing, for a period of not exceeding five years at one time, the amount and value of such property for the purposes of taxation; and

WHEREAS, it is deemed for the best interests of the City of Providence and of the Town of Scituate that an agreement be entered into under the authority contained in said act;

NOW, THEREFORE, it is agreed by and between the parties hereto:

That for the assessment of town valuations as of December 31, A. D. 1955 and for the next four succeeding dates of assessment of town valuations by the Tax Assessors of the Town of Scituate on the ratable property located in said town on said dates of assessment of town valuations, the valuation of the ratable property owned by the City of Providence and located in said Town of Scituate on said dates is hereby fixed at Six Million Seven Hundred Ninety Thousand (\$6,790,000.00) Dollars and shall remain so fixed regardless of any increase or decrease in the valuation of the ratable property of the City of Providence located in said Town of Scituate during said period. This agreement shall cover all assessments made during the five year term from and including December 31, A. D. 1955 to and including December 31, A. D. 1959.

It is further agreed that in making said assessment the Assessors of Taxes of said Town of Scituate shall not be

required to list each parcel separately and shall not be required to list land, buildings and other improvements and tangible personal property in separate columns.

The Town of Scituate hereby agrees not to carry on its assessment rolls, during said period, any sum other than the amount above stated.



THIS INDENTURE OF LEASE made and entered into on this 1st day of July, A. D. 1955, by and between the City of Providence, a municipal corporation created by the General Assembly of the State of Rhode Island, hereinafter called the Lessor, and Saint Joseph's Church Corporation, North Scituate, a corporation organized under the laws of the State of Rhode Island and located in North Scituate, Rhode Island, hereinafter called the Lessee,

W I T N E S S E T H:

That the said Lessor, for and in consideration of the rents and covenants hereinafter specified, and contained, on the part of said Lessee, its successors and assigns, to be kept and performed, does hereby demise and lease unto the said Lessee, its successors and assigns, for and during a term of fifty (50) years, beginning on the first day of July, A. D. 1955, that certain tract or parcel of land located in the Town of Scituate, bounded and described as follows:

Beginning at the northwest corner of Parcel 1107-C as shown on Sheet A-3 of Plat of Lands Condemned by the City of Providence for Water Supply purposes in the Town of Scituate, R. I.; thence in a generally westerly direction Seventy-eight and Twenty Hundredths (78.20) feet to a stone bound; thence in a generally westerly direction, forming an interior angle of One Hundred and Eighty (180) degrees, Twelve (12) Minutes and Fifty-four (54) seconds, Sixty-eight and Twenty Hundredths (68.20) feet; thence in a generally southerly direction, forming an interior angle of Ninety-one (91) degrees, Seventeen (17) minutes and Two (2) seconds, Eighty-four and Eleven hundredths (84.11) feet; thence in a generally easterly direction, forming an interior angle of Ninety (90) degrees, Three (3) minutes and One (1) second, Two Hundred Twenty-nine and Ninety-four Hundredths (229.94) feet; thence in a generally northerly direction, forming an interior angle of Eighty-nine (89) degrees, Fifty-six (56) minutes and Fifty-nine (59) seconds, Eighty-seven and Eighty-nine Hundredths (87.89) feet; thence in a generally westerly direction, forming an interior angle of Ninety (90) degrees, Eighty-three and Fifty-eight Hundredths (83.58) feet to the point of beginning and forming an interior angle with the first described course of One Hundred and

Seventy-eight (178) degrees, Thirty (30) minutes and Four (4) seconds; said tract containing Forty-six Hundredths (0.46) acre and being a part of Parcels 240-C and 1107-C as shown on Sheet A-3 of Plat of Lands Condemned by the City of Providence for Water Supply purposes in the Town of Scituate, R. I., all as shown on that certain plat entitled "City of Providence, Water Supply Board, Land Proposed to be leased to Saint Joseph's Church Corporation, North Scituate, dated 2/1/55, No. 3961, approved by Philip J. Holton, Jr., Chief Engineer", a copy of which plat is attached hereto and made a part hereof by reference.

TO HAVE AND TO HOLD the same, with all the rights and privileges thereof unto the said Lessee, its successors and assigns, for and during a term of fifty (50) years from the first day of July, A. D. 1955, it yielding and paying therefor as a yearly rent, the sum of one (\$1.00) dollar and an additional sum equal to the taxes which may be assessed thereon and/or upon any and all improvements placed thereon, annually or otherwise by the Town of Scituate or other governmental body, the same to be paid within one (1) month of the assessment of said tax.

Provided always, and this lease is made upon the following express conditions:

1. That the said Lessee during the continuance of this lease shall use and occupy the aforescribed premises as a parking area for the parishioners of the Lessee corporation and/or for other purposes connected with the administration, operation and functioning of the Lessee corporation and for no other purposes whatsoever.
2. That the Lessee shall observe and abide by all statutes, laws, ordinances, rules and regulations which are now in force or which may be hereafter enacted with respect to such occupancy.
3. That the Lessee shall not use or suffer said premises, or any part thereof, to be used or occupied for any unlawful business or any unlawful purposes whatsoever. And it will

preserve the peace and maintain good order on said premises at all times; that it will not assign or sublet the whole or any part of the demised premises nor shall it part with the possession of the whole or any part of the demised premises without obtaining the written consent of the Lessor, acting by and through the Water Supply Board of the City of Providence.

4. That any improvements erected on said demised premises are to be held at the sole risk of the said Lessee, its successors and assigns.

5. That the Lessee shall not use the aforescribed premises or any improvements which may be erected thereon, in such manner as to cause any pollution of the water supply of the City of Providence stored and controlled in the area of the demised premises by the Lessor.

6. That the Lessor shall have the right at all times to enter upon the premises herein demised and to make such inspection as it deems desirable for any purpose whatsoever, the Lessee hereby covenanting that it will not interfere with or restrict any such entry by the Lessor, but will cooperate in making the premises available for any such inspection.

7. That upon any violation of any of the foregoing conditions or covenants, the said Lessor, by any agent duly authorized, shall be at liberty to terminate this lease and may thereupon lawfully, immediately or at any time thereafter, and without notice or demand, enter into and upon said premises and repossess the same as of its former estate.

8. It is understood and covenanted by and between the parties hereto that the Lessee shall within sixty (60) days from and after the expiration or other termination of this lease, remove any and all buildings, structures and other improvements placed on the premises herein demised by the Lessee. And if



the same shall not be so removed, the said improvements shall, at the option of the Lessor, become its sole and lawful property, or the said Lessor may remove the same at the expense of the Lessee, which shall be liable to the Lessor for all cost incurred by the Lessor in the removal of the buildings and improvements.

9. It is further understood and agreed by and between the parties hereto that all buildings and improvements erected or placed upon said land are and shall be pledged and constitute a first lien for the payment of all rents accruing or owing under this lease.

IN TESTIMONY WHEREOF, said City of Providence has caused these presents to be executed and its corporate seal to be hereunto affixed by Walter H. Reynolds, its Mayor, thereunto duly authorized by City Council Resolution No. , approved 1955; and said Saint Joseph's Church Corporation, North Scituate, has caused these presents to be executed and its seal to be hereunto affixed by a duly authorized officer of the corporation.

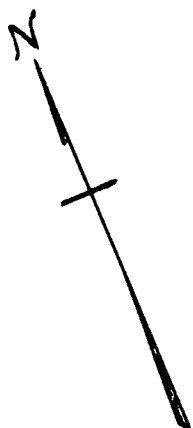
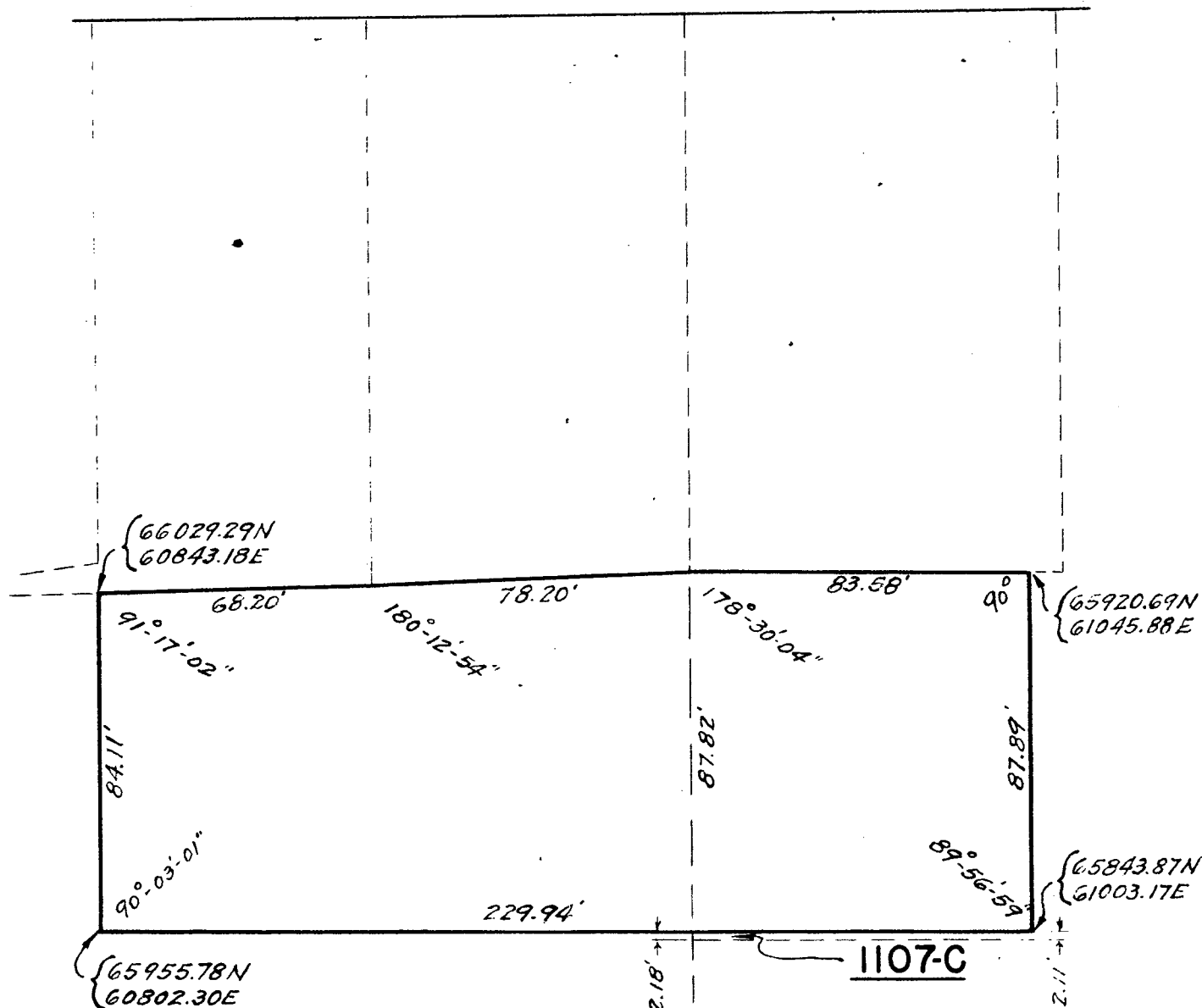
